On behalf of various departments, recommend to accept the best bid from Postal Presort, Inc. at the rates listed for one (1) year with two (2), one (1) year options to renew.

The county has been outsourcing mailing services for large jobs such as tax statements and appraisal notices for many years. Due to changing markets and advances in digital technology, it has become clear that the most efficient way to proceed with these services is to have the mailing vendor also do the printing. This process starts with the county sending an electronic file to the vendor, the vendor then prints our files as instructed by the department, the department views several samples of files being printed for quality assurance and the vendor will then fold, stuff and process for bulk mailing service. Postal Presort will print all statements, inserts and envelopes and process for mailing at the rates listed above.

Last year the county spent approximately $\$45,\!000.00$ on mailing services alone.

The Treasurer and Appraiser, who are the key stakeholders of this contract, are willing to pay the additional costs for the efficiency these services will provide.

Postal Presort is currently providing mailing services to the county and has also provided these services in the past.

Notes:

Handy Mailing Service will only guarantee a maximum of 30,000 1-sided pages (clicks) per day. This quantity is unacceptable to the county as the county's print shop uses a machine that runs 10,800 clicks per hour, which works out to be 86,400 clicks per day.

Stampede Mailing Services bid on mailing services only.

The county is not interested in contracting with a vendor outside of Wichita. This has been done in the past and caused numerous problems related to service and time constraints. Due to statutes regulating the receipt of certain statements by residents, the county cannot afford to miss a deadline. KC Presort and Stampede Mailing Services are both located outside of Wichita.
