On the recommendation of Kristen McGovern, on behalf of Public Works, Jennifer Dombaugh moved to **accept the bid from Andale Construction, Inc. in the amount of \$1,234,645.34.** Linda Kizzire seconded the motion. The motion passed unanimously.

Super Seal is a cementitious material used to stabilize the subgrade for selected county roads.

Andale Construction, Inc. is currently the only vendor experienced in this process.

This application method for Super Seal has been in existence and practice worldwide for decades but has not been used in this area until recently. There is only one contractor in the local market who is equipped and experienced in this application method. Public Works continues to monitor the cost of this type of application against the cost of other methods and materials, that provide a similar end product to ensure that the county is getting the best possible value.

Question: How many miles of road does this cover? 3.69 miles.

On the recommendation of Kimberly Evans, on behalf of various county departments, Jennifer Dombaugh moved to **utilize State of Kansas Contract 39005 with Underground Vaults and Storage, dba Document Resources (UVS) and establish contract pricing through March 31, 2019.** Linda Kizzire seconded the motion. The motion passed unanimously.

UVS has been the county contracted vendor for document storage for over a decade and provides storage, retrieval and destruction of stored documents that fall under retention guidelines set forth by K.S.A. 45-404(g), 45-406(d) and 45-404(b).

The county previously held a contract with Shred-It, LLC for shredding services, and due to numerous service and billing issues, the vendor was placed on probation in December of 2015. Once the probation period ended, the vendor was still not meeting the service terms of the original contract and it was therefore decided to terminate this contract and seek services from another provider. Since UVS currently handles other document services for the county and currently holds the State of Kansas contract for shredding services, it was agreed that utilizing the existing state contract would be in the best interest of all parties involved.

Last year, the county spent approximately \$26,000.00 on shredding services.

Question: When will the new vendor take over? July 1st.

A committee consisting of Talaya Schwartz, Brenda Gutierrez - COMCARE , Jeannette Livingston - CDDO, Tim Kaufman, Director , Division of Health and Human Services, Jodi Tronsgard, Mario Salinas - Department of Corrections, Marty Hughes - Division of Finance and Britt Rosencutter - Purchasing evaluated all proposal responses, based on the goals of the Committee overseeing prevention and early intervention services, proposal content, cost, qualifications, experience of the agency, and the availability of the agency to work with those being served.

Sedgwick County is allocating approximately \$662,000.00 annually in support of prevention and early intervention programs targeted to youth at risk for juvenile delinquency.
