Discussion

Judge Fleetwood called the meeting to order. No quorum present.

1. Approval of Minutes
 - a. August 27, 2015 minutes were approved
 - b. September 24, 1015 minutes were approved
2. New Business
 - a. Criminal Justice System Population Discussion
 - i. Mr. Masterson asks why there is such an unusual spike on slide 3. He questions the accuracy and whether or not it is an anomaly. Ms. Dietzman says she will check on it.
 - b. Determine Meeting Schedule for Nov/Dec (Duncan)
 - i. Mr. Marv Duncan says that in the past they have combined the November and December meetings. Last year the meeting was held on a Thursday early in December. Commissioner Norton asks if there is a suggested date. Mr. Duncan responds that he recommends the 3rd. It is agreed upon to meet December 3rd.
3. Old Business
 - a. Approve CJCC items for BOCC legislative platform
 - i. Mr. Duncan says the legislative platform is what CJCC has been interested in in the past.
 - ii. 3: Appearance Bond Revocation Process (Masterson)
 1. Mr. Duncan mentions that Mr. Masterson is here and available to answer questions. Mr. Masterson states that many groups have the ability to request an arrest and detain. Pre-trial services does not have that

authority and is therefore required to go through the warrant process. What we are trying to do is allow pre-trial services officers to have the arrest and detain authority.

- iii. C2: Bonding process (no change) (Duncan/Fleetwood)
- iv. C4: Driving While Suspended Look Back (no change) (Duncan) 8 min
- v. C6: Jail Population – Key Issues of State Prisoners in County Jails (updated) (Duncan/Easter)
- vi. C7: Increase Funding for State-Mandated Community Corrections (updated) (Masterson)
 - 1. Mr. Duncan indicates that Mr. Masterson has updated this slightly. Mr. Masterson says that this is essentially a question of funding. Additional funding for provision officers is required because there have been changes to training and practices.
- vii. C8: Increase Funding for Community Corrections (updated) (Masterson)
 - 1. Mr. Masterson says this is about the adult residential center. Historically, the State funds two of these facilities; one in Johnson County and one in Sedgwick County. Since 1990...
- viii. Judge Fleetwood says that these changes are for the BoCC legislative platform. They typically take a vote to formally adopt these items for the BoCC legislative platform. Majority approved.

4. Other Business

- a. Councilwoman Williams mentions that she was on a conference call yesterday and believes that mental health is part of the criminal justice system. Commissioner Norton notes that the divestiture discussion is still ongoing. Commissioner Norton would like to see a community dialogue over how to start fixing the criminal justice system and the social service aspects of the County. District Attorney Bennett mentions that it would take a lot more than just Sedgwick County.
- b. Judge Fleetwood asks if Commissioner Norton is suggesting that CJCC should be hosting this. Commisioner Norton says that CJCC could host something for the criminal justice aspect, but there is likely a larger conversation to be had. District Attorney Bennett mentions that they could do this type of thing at the 4H building. Perhaps we could work with WSU. Commissioner Norton mentions that the Hugo Wall School is good at getting these things together. Commissioner Unruh mentions that someone that is not Sedgwick County is going to have to be a driver, but Sedgwick County should be supportive.
- c. Judge Fleetwood asks if Mr. Masterson has an idea. Mr. Masterson asks (Marilyn Cook) (27 minutes). Judge Fleetwood says we should have this on the next meeting's agenda. Mr. Masterson asks if what he testified on for the Governor's Mental Health Task Force has had an impact. Ms. Marilyn Cook says she has not seen anything. Commissioner Norton says ultimately the community has to do the mental health programs.
- d. Commissioner Unruh asks Ms. Cook what she knows about the RFP. Ms. Cook says that her understanding is that at this time the Commission is waiting until the new manager comes on board before they release the RFP.
- e. Judge Fleetwood asks if it makes more sense to have a steering committee. Lavonta
- f. Mr. Masterson asks are we asking for information or are we asking for proposals. Commissioner Norton said the community health conference was both. Commissioner Norton says that much of what has changed at the health department and the work has been done to improve public health. Commissioner Unruh wants a recommendation to come out of this body as to whether a privatized system is going

to be good or bad. His hope would be that out of the conference that they've been talking about, this is the result he would like to see.
