The following is to ensure that vendors have complete information prior to submitting a proposal. Here are some clarifications regarding the bid for one (1), One-Ton Extended Cab/Super Cab, Single Rear Wheel, 4-Wheel Drive with Utility Bed for Fleet Management.

Questions and/or statements of clarification are in **bold** font, answers to specific questions are *italicized*.

1. Please clarify single rear wheel chassis with a body to fit dual rear wheel chassis.

Correction to Specification #7 a. Replace with "Equal to or better than a Knapheide 696FJ40." Correction to Specification #7b. Current utility box measurements.

- 1) Rear compartment 40"H x 21"W x 13"Deep
- 2) Middle compartment 18"H x 44"W x 13"Deep
- 3) Front compartment 40"H x 31"W x 13"Deep
- 2. Keyless entry remotes do you want the body to have keyless entry or just the truck?

Answer: Keyless entry on truck only. Utility box needs to lock with key.

3. The Code 3 2700 series is a series of light bar and has numerous options available. Please specify what you want the light bar to consist of.

Answer: Light bar to be equivalent to Code 3 Model 2147A30H. Has stop, turn, tail on rear with two (2) amber lights and two (2) work lights. Four (4) each corner lights amber, and two (2) amber lights in front.

4. Would you except cloth seats?

Answer: Yes, but it is not preferred.
