1) Please make note of the change made to our section 7. Minimum Requirements and Specifications for Shirts for item c (rewritten as follows):

"The front of the shirt shall include an embroidered badge on the left breast. This design has already been made by the specialty design team at 5.11 and the vendor will order the shirt with the badge already placed by the manufacturer, 5.11 *or provide equal quality embroidery of embroidered badge*. The 5.11 representative most knowledgeable of this process is Andy Neuberger (<u>AndrewN@511tactical.com</u> or 913-226-8578).
