On the recommendation of Joe Thomas, on behalf of various departments, Sara Jantz moved to accept the proposals from Interpreters Unlimited, Foreign Language Interpreter Services, and Interlingual Services for in-person services, Propio Language Services for telephonic services, and All Global Solutions International, Inc. and Interlingual Services for document translation services as itemized in their respective proposals and establish contract pricing for a two (2) year period with a one (1) year option to renew. Jenifer Dombaugh seconded the motion. The motion passed unanimously.

A committee comprised of Jeannette Livingston - Contract Administrator - COMCARE, Ellen House - Court Administrator - 18th Judicial District Court, Matthew Kitchen - Sedgwick County Offender Assessment Program, Shantel Randolph - Program Manager - COMCARE Children's Services, Nancy Patterson - COMCARE Crisis Intervention Services, Kathryn Foster - COMCARE Outpatient Services, Amanda Matthews - Communications, Lisa Avila - Health Department, and Joe Thomas - Purchasing reviewed and evaluated each proposal for methodology, timeliness of service, languages offered, and costs. Eight (8) vendors were shortlisted and interviewed and references were checked.

On-call translation and interpretation services will be utilized by various departments in order to assist Limited English Proficiency (LEP) individuals using the above methodologies. The services provided will be available on a 24/7/365 basis.

#### **BOARD OF BIDS AND CONTRACTS JULY 28, 2011**

During 2010, COMCARE spent over \$34,000.00 for in-person and telephonic services, District Courts spent approximately \$65,000.00 for in-person services, and the Department of Corrections spent approximately \$1,500.00 for telephonic services.

Note:

\* *Reliable Interpretations and Translations* provides no service after 5:00 pm. A \$15.00 travel charge is billed if the translator drives more than 35 miles. A 1-hour charge is billed if a cancellation is less than a 2-hour notice.

\*\* Carmazzi Global Solutions may require a travel fee.

\*\*\* Foreign Language Interpreter Services charges for 1 hour if a cancellation is less than a 90 minute notice.

# Languages Translation Services requires 12 hours notice for cancellation or payment in full is required.

## All Global Solutions International, Inc. requires minimum 1 hour cancellation notice.

### The Language Banc, Inc. requires a minimum 2 hour cancellation notice or \$30.00 flat fee will be charged.

^ Leyda's Services bills a 1 hour charge for cancellations or no-shows.

^^ International Translation Services rounds to the next 30 minutes for partial hours after the first hour.
