## ADDENDUM 2 #15-0095 PUBLIC SAFETY UNIFORMS AND WEB-BASED ORDERING SYSTEM

October 9, 2015

In order to ensure vendors have access to complete information prior to submitting a response, Sedgwick County issues a written addendum regarding all questions and requests for clarification received. The following questions have been received to date regarding the above mentioned solicitation.

- 1. Is this an all or nothing RFP, do you have to bid on all items? This is not all or nothing, it is the desire of Sedgwick County to award to one vendor, but we may choose to award to multiple vendors. You may bid on all or some of the items.
- 2. Under Appendix A, Overall how will pricing be evaluated? Pricing of garments, shoes, misc. items, etc. will be taken into consideration but will not be the sole determining factor.
- 3. Under Appendix A, How many of the products on this bid are new products that the agencies are not currently utilizing? Sheriff's Office and EMS-one item each, Fire District, Corrections and Courthouse Police-None
- 4. Under Appendix A, EMS Misc. Items, Pro-Tech A-Bravo Helmet: matte red with rail mounts and Velcro: Pro-Tec does not have a manufacturer number 4811931RML, is there another number that may work? The correct item number is 481193RMIL.
- 5. Under Appendix A, EMS, Shoes, Thorough High Gloss Academy Oxford Shoes: the manufacturer stated that the first shoe does not exist, please clarify who the manufacturer is. Thorogood Poromeric Academy Gloss Black Leather Oxford Service Shoe. Manufacture item number: AS SX0
- 6. Under Appendix A, Fire District, Tops, short sleeve and long sleeve crew t-shirt, 100% cotton, navy and white, item numbers 1005-8S and 1005-8L: Who is the vendor/manufacturer? Please use Port and Company, Essential T-Shirt, item numbers PC61 and PC61T
- 7. Under Appendix A, Fire District, Misc. items: what finish is needed for the Blackington items? The gold items are Hi Glo and the silver items are Rhodium.
- 8. Under Appendix A, Fire District, Misc. items, Boston 1 ½" Leather Belt, Black with Silver or Gold, item numbers 6582 and 6582G: what finish do you need? **Plain Finish**
- 9. *Under Appendix A, Sheriff's Office, Tops, Oxford button down short-sleeve and long-sleeve shirt, 65/35 Poly Blend, Multiple Colors: Are these shirts the Edwards shirts?* **Yes.**

- 28. Under Appendix A, Sheriff's Office., Misc. - 29. Under Appendix A, Sheriff's Office., Misc. Items, Clip-on Badge Holder, Black: Can you please provide the part numbers, fabric content, specific color names, and all other details pertaining to these items? Safariland 7350 badge clip.
- 30. Under Appendix A, Sheriff's Office., Misc. Items, Felt Champaign Hat with Adjustable Leather Chinstrap, Navy: Can you please provide the part numbers, fabric content, specific color names, and all other details pertaining to these items? Stratton brand, item number 4303.
- 31. Under Appendix A, Sheriff's Office., Misc. Items, Classic Style Watch Cap with Thinsulate, Navy: Can you please provide the part numbers, fabric content, specific color names, and all other details pertaining to these items?

- 32. Under Appendix A, Sheriff's Office., Bottoms, LawPro 1-1/2" Wide Leather Garrison Belt, Black, Misc. Items, Galls Felt Campaign Hat with Adjustable Leather Chinstrap, Navy, Quartermaster Campaign Hat Rain Cover, Clear, and Quartermaster Campaign Cords, Silver/Gold: By putting a specific bidder's proprietary products in the RFP, it completely eliminates competition and ensures that no other company can bid. Will these products remain or will a specification that allows other bidders be offered? The specifications and brands outlined in the RFP are intended to serve as minimum specifications and bidders responding to the RFP shall meet or exceed the listed specifications.
- 33. When will any contract arising from this bid begin? After final approval by the Board of County Commissioners.

- 34. On page one of the RFP it says questions of a substantive nature will be responded to. Does that mean that you will decide which questions to answer and not answer? All questions pertaining to the proposal will be answered in addendum form.
- 35. How are we to handle questions that arise out of answers to these questions? If need be, additional addenda will be issued.
- 36. Under Mandatory Requirements, Vendor Requirements, item e: Have or have plans for a local office OR a local subcontractor.
  - a) As it relates to a subcontractor, some manufacturers have not historically extended product warranties when those products are altered by the employees of a company that they have not approved as a dealer: Is this acceptable to the County? Any warranty issues will be worked out with the contracted vendor.
  - b) What if said Vendor does not open said office? What if those plans change but the promise of a local office was considered in awarding a vendor this business? A local presence, whether that be a storefront or a subcontractor is mandatory.
  - c) Will a local office or subcontractor be expected to have seamstresses and embroidery staff on hand 40 hours a week? That will be up to the discretion of the vendor, Sedgwick County does expect the vendor to meet embroidery and alteration deadlines.
  - d) Will a local office or a local subcontractor be expected to be open at least 40 hours per week and staffed in a manner to handle at least three people at one time as routinely occurs with County employees currently? That decision will be up to the discretion of the vendor; Sedgwick County does expect the vendor to meet the County's needs.
  - e) Will a local office or local subcontractor be required to keep the inventory for this contract on hand as opposed to spread out in different locations throughout the United States? Some inventory will need to be kept on hand. See section 5, Mandatory Requirements, Vendor Requirements, item L.
  - f) Will a size run, which typically consists of one of each size, be considered adequate inventory? No. See question 40
  - g) Is the expectation of the County that non-embellished items be available at said location so that a member of any of the County Department's could walk in and pick them up the day they are needed? **Yes.**
- 37. Under Vendor Requirements, item f, be willing to come onsite to measure employees for uniforms, answer questions, or to solve issues within 72 hours of a request: It seems to require that staff be on hand at the location of any county department within 72 hours of it being requested. Is that the intent of this point? At times, yes.
- 38. Under Vendor Requirements, item j, be able to provide alterations, embroidery, screen-printing, etc: is this expected to be done locally in Sedgwick County? **No.**
- 39. Under Vendor Requirements, item e, Have or have plans for a local office OR a local subcontractor: is it an expectation that these alterations do not void any manufacturer's warranty? The expectation is that all respondents address this in their response.
- 40. Under Vendor Requirements, item l, Maintain stock inventory for popular items in standard sizing: is one of each popular size adequate? Would 10% of annual estimated usage on hand in Sedgwick County be more measurable and appropriate? 10% of annual usage

- 41. Under Vendor Requirements, item m, be willing to provide a demo of your web-based ordering system (in real-time) during the evaluation period: What type of notice will we receive relating to providing a demo of our web system? Who will be present at the demonstration? Will each department covered by this RFP have representation at this demonstration? You will receive at least a 48 hour notice. Each department will be represented.
- 42. Under Uniform Requirements, item b, be shipped within three to five business days after processed order: Clarification: Sedgwick County expects all in-stock orders to be shipped within 3-5 business days.
- 43. Under Uniform Requirements, item c, any backordered items must be delivered within two (2) weeks after receipt of order: Does this mean they are to be delivered within 2 weeks after the back ordered item has been delivered from the manufacturer to the bidder? Please disregard this item, Sedgwick County will work with the vendor when backorders occur.
- 44. Under Uniform Requirements, item d, inform department/employee of receipt of PO or online order via confirmation of items ordered, additional patches, embroidery, brass, etc.: Can you please clarify what the last part of this sentence means? Sedgwick County is requiring that communication in the form of a confirmation when a PO or online order is placed, whether that be uniforms, patches, embroidery, brass, etc.
- 45. Under Uniform Requirements, item g, be warranted free from defects in materials and workmanship for a period of one year from delivery. If a bidder uses a subcontractor that is not an approved point of distribution and thus voids a manufacturer's warranty, it would make this item impossible. The expectation is that all respondents address this in their response.
- 46. Under Web-Based Ordering System, item a, provide adequate information to employees using the web-based ordering system: Please clarify what is considered adequate information. An employee should be provided enough information, by the contracted vendor, to successfully navigate the web-based ordering system.
- 47. Will each department that this RFP is for have representation on this committee and have an equal say in the final decision? A member from each department will be participating in the final decision.
- 48. Will all members of the committee be involved in checking references so that all committee members hear the same information from those references? **Reference checks will be done by the committee.**
- 49. Will there be a method of evaluation of each of the criteria that is measurable and transparent such as an equal amount of points per evaluation criteria? A total number of points for each area of measurement? Please refer to section 6, Selection Criteria, of the RFP.
- 50. What if bidders no bid some items? **See question 1.**
- 51. Will there be an expectation that any bidder prove their ability to match existing embroidery designs by submitting designs with the bid? Sedgwick County will work with the vendor to ensure embroidery is to our satisfaction.
- 52. How will "of equal or greater quality" be specifically and deliberately measured? Each department will determine what is of equal or greater quality.
- 53. Will wear tests be involved in measuring "of equal or greater quality"? Possibly, but that decision will lie with the department.
- 54. Will all evaluations be completed prior to the awarding of the RFP? Yes.

- 55. Will each agency be making the decision related to "of equal or greater quality" themselves via a measurement tool that will provide transparency while giving each agency the opportunity to decide what is best for their people? Each department will be determining equal or greater quality for their specific specifications.
- 56. Included is a new copy of Appendix A with updated information from this addendum.
