REQUEST FOR PROPOSAL #15-0120 TENDER/PUMPER TRUCKS

Sedgwick County, Kansas (hereinafter referred to as "County") is seeking to obtain proposals from vendors to provide two (2) TENDER/PUMPER TRUCKS for Sedgwick County Fire District #1. It is anticipated that an official purchase order will be issued after Board of County Commission approval of the recommended proposal. It should be noted, however, that the County cannot guarantee the purchase of the product described herein.

Carefully review this Request for Proposal. It provides specific technical information necessary to aid participating firms in formulating a thorough response. To ensure that vendors have complete information prior to submitting a bid, a prebid meeting has been scheduled for January 7, 2016 beginning at 1:00 p.m. CST in the Finance Conference room located in the Sedgwick County Finance Department, 525 N. Main St., Ste 823, Wichita Kansas. Should firms elect to participate, one (1) complete original, one (1) copy and one (1) electronic copy on a CD or USB flash drive (including all supplementary materials) must be completed and returned to:

1. ABOUT THIS DOCUMENT

This document is a Request for Proposal. It differs from a Request for Bid or Quotation in that the County is seeking a solution, as described on the cover page and in the following background information section, not a bid or quotation meeting firm specifications for the lowest price. As such, the lowest price proposed will not guarantee an award recommendation. As defined in Charter Resolution No. 65, Competitive Sealed Proposals will be evaluated based upon criteria formulated around the most important features of the product(s) and/or service(s), of which quality, testing, references, service, availability or capability, may be overriding factors, and price may not be determinative in the issuance of a contract or award. The proposal evaluation criteria should be viewed as standards that measure how well a vendor's approach meets the desired requirements and needs of the County. Criteria that will be used and considered in evaluation for award are set forth in this document. The County will thoroughly review all proposals received. The County will also utilize its best judgment when determining whether to schedule a pre-proposal conference before proposals are accepted, or meetings with vendors after receipt of all proposals. A Purchase Order/Contract will be awarded to a qualified vendor submitting the best proposal. Sedgwick County reserves the right to select, and subsequently recommend for award, the proposed service(s) and/or product(s) which best meets its required needs, quality levels and budget constraints.

The nature of this work is for a public entity and will require the expenditure of public funds and/or use of public facilities, therefore the successful proposer will understand that portions (potentially all) of their proposal may become public record at any time after receipt of proposals. Proposal responses, purchase orders and final contracts are subject to public disclosure after award. All confidential or proprietary information should be clearly denoted in proposal responses and responders should understand this information will be considered prior to release, however no guarantee is made that information will be withheld from public view.

2. GENERAL & BACKGROUND INFORMATION

Sedgwick County, located in south-central Kansas, is one of the most populous of Kansas' 105 counties with a population estimated at more than 508,000 persons. It is the sixteenth largest in area, with 1,008 square miles, and reportedly has the second highest per capita wealth among Kansas counties. Organizationally, the County is a Commission/Manager entity, and hosts or provides a full range of municipal services, e.g. – public safety, public works, criminal justice, recreation, entertainment, cultural, human/social, and education. In accordance with the specifications outlined here, it is the intent to receive proposals to provide two (2) TENDER/PUMPER TRUCKS for Sedgwick County Fire District #1.

3. MINIMUM QUALIFICATIONS

The successful proposer must:

- 3.1 Have an established reputation in the field of fire apparatus construction and have been in business for a minimum of 20 years, including experience with the equipment, technical ability, personnel and facilities to properly complete, coordinate and administer the contract, if awarded.
- 3.2 Have proven ability to provide high quality service(s) and/or product(s) within the specifications, mandatory requirements, miscellaneous instructions and conditions as outlined in this and future related documents.
- 3.3 Provide products/services following all applicable federal, state, and local laws, regulations, and ordinances.

4. GENERAL REQUIREMENTS

- 4.1 New current models shall be used.
- 4.2 Provide manufacturer name, model proposed and include specifications.
- 4.3 Provide a lead time for production.

5. SELECTION CRITERIA

The selection process will be based on the responses to this Request for Proposal and any interviews required verifying the ability of proposer to provide services in accordance with this document. A committee will evaluate each proposer's response as determined by meeting the following criteria (ranked in no particular order):

• Demonstrate clearly and completely your ability and capacity to meet all Request for Proposal conditions and miscellaneous instructions as outlined herein, and the clarity, completeness and comprehensiveness of the proposal

- Proven ability to provide high-quality products with superior service within the specifications, mandatory requirements, miscellaneous instructions and conditions as outlined in this and future related documents. Such ability will be determined by:
 - o Providing four (4) references verifying exemplary service. These references MUST have received service(s) and/or product(s) similar to those proposed under this RFP. Provide the business name, address, contact name, phone number, e-mail address and a brief description of product(s) provided.
 - o Meeting or exceeding all provider qualification requirements and/or specifications as outlined herein; and
 - o Providing the County with the most advantageous proposal.

Those submitting a proposal do so entirely at their own expense. There is no expressed or implied obligation by Sedgwick County to reimburse any individual or firm for any cost incurred in preparing or submitting proposals, providing additional information when requested by Sedgwick County or for participating in any selection interviews.

County reserves the right to reject any proposal, determine any irregularities, and make final determination for award.

No negotiations, decisions, or actions will be initiated by any firm as a result of any verbal discussion with any County employee during the request for proposal process. Sedgwick County reserves the right to select the service(s) and/or provider(s), and subsequently recommend for award, the proposed services that best meets required needs, quality levels, and budget constraints.

8. INSURANCE REQUIREMENTS

Liability insurance coverage indicated below must be considered as primary and not as excess insurance. Contractor shall furnish a certificate evidencing such coverage, with County listed as an additional insured, except for professional liability, workers' compensation and employer's liability. Certificate shall be provided with bid/proposal submittals. Certificate shall remain in force during the duration of the project/services and will not be canceled, reduced, modified, limited, or restricted until thirty (30) days after County receives written notice of such change. All insurance must be with an insurance company with a minimum BEST rating of A-VIII and licensed to do business in the State of Kansas. It is the responsibility of Contractor to require that any and all approved subcontractors meet the minimum insurance requirements. Contractor shall obtain the above referenced certificate(s) of insurance, and in accordance with this Agreement, provide copies of such certificates to County.

Commercial General Liability Insurance

The successful bidder shall, during the performance of the contract and for three (3) years following acceptance of the product, keep in force at least the following minimum limits of commercial general liability insurance:

Each Occurrence \$1,000,000.00 Products/Completed Operations Aggregate \$1,000,000.00 Personal and Advertising Injury \$1,000,000.00 General Aggregate \$5,000,000.00

Coverage shall be written on a Commercial General Liability form. The policy shall be written on an occurrence form and shall include Contractual Liability coverage for bodily injury and property damage subject to the terms and conditions of the policy. The policy shall include Owner as an additional insured when required by written contract.

Commercial Automobile Liability Insurance

The successful bidder shall, during the performance of the contract keep in force at least the following minimum limits of commercial automobile liability insurance:

Each Accident Combined Single Limit: \$1,000,000.00 Coverage shall be written on a Commercial Automobile liability form.

Umbrella/Excess Liability Insurance

The successful bidder shall, during the performance of the contract and for three (3) years following acceptance of the product, keep in force at least the following minimum limits of umbrella liability insurance which provides "following form coverage to the underlying coverages."

Aggregate: \$25,000,000.00 Each Occurrence: \$25,000,000.00

The umbrella policy shall be written on an occurrence basis and at a minimum provide excess to the Bidder's General Liability, Automobile Liability and Employer's Liability policies.

The required limits can be provided by one (1) or more policies provided all other insurance requirements are met. Coverage shall be provided by a carrier(s) rated A- or better by A.M. Bests. All policies shall provide a thirty (30) day notice of cancellation to the named insured. The Certificate of Insurance shall provide the following cancellation clause: Should any of the above described polices be cancelled before the expiration date thereof, notice shall be delivered in accordance with the policy provisions. Bidder agrees to furnish owner with a current Certificate of Insurance with the coverages listed above along with its bid. The certificate shall show the purchaser as certificate holder.

9. INDEMNIFICATION

To the fullest extent of the law, the provider, its subcontractor, agents, servants, officers or employees shall indemnify and hold harmless Sedgwick County, including, but not limited to, its elected and appointed officials, officers, employees and agents, from any and all claims brought by any person or entity whatsoever, arising from any act, error, or omission of the provider during the providers performance of the agreement or any other agreements of the provider entered into by reason thereof. The provider shall indemnify and defend Sedgwick County, including, but not limited to, its elected and appointed officials, officers, employees and agents, with respect to any claim arising, or alleged to have arisen from negligence, and/or willful, wanton or reckless acts or omissions of the provider, its subcontractor, agents, servants, officers, or employees and any and all losses or liabilities resulting from any such claims, including, but not limited to, damage awards, costs and reasonable attorney's fees. This indemnification shall not be affected by any other portions of the agreement relating to insurance requirements. The provider agrees that it will procure and keep in force at all times at its own expense insurance in accordance with these specifications.

10. TERMINATION

The County reserves the right to cancel the contract and discontinue services with a ninety (90) day written notice as a result of the failure of the contracted provider to provide acceptable services as delineated in the response to this document or if determined that services can be better provided by in-house or other sources. In the event of termination of this agreement as a result of a breach by contractor hereunder, the County will not be liable for any fees and may, at its sole option, award an agreement for the same services to another qualified firm with the best proposal, or call for new proposals and award an agreement for the same services to another qualified firm to provide services.

In submitting a response to this Request for Bid, vendors hereby understand the following as applicable: General Contractual Provisions

13. PROPOSAL CONTENT

The proposal response should be organized in the following format and information sequence:

- 1. State full name and address of your organization and provide a brief description of your firm, including qualifications, experience, depth of staff, quality control, and the demonstration of your ability to deliver a quality product.
- 2. Provide a list of four (4) past or current client references; include organization, address, date of services, scope of services/products, contact person, telephone number, and an email address.
- 3. Clearly address in sequential order each of the minimum qualifications listed in Section 3.
- 4. Clearly address in sequential order each of the specifications and requirements listed in Section 8. Include Bid Bond, copy of insurance and warranty information. *Proposers must clearly delineate and describe in detail any exceptions to the requirements and specifications.*
- 5. Sign and return the completed Proposal Response Form that is provided on pages 57.

14. SPECIFICATIONS and REQUIREMENTS

Proposals taking total exception to specifications shall not be acceptable. Bidders shall submit a detailed proposal. A letter only, even though written on a company letterhead, shall not be sufficient. Bid proposals shall be submitted in the same sequence as specifications for ease of evaluation, comparison and checking of compliance. Any exception to these requirements shall not be tolerated.

This document has several headings, which are in bold type and underlined. The headings should be considered a question on how the manufacturer will complete the item or how the manufacturer meets or intends to meet the qualifications set forth.

- A. Sedgwick County Fire District #1 will require certain items to be used in the manufacturing of this apparatus. Under certain headings this equipment or method of construction will be noted as a specification. These specifications point out the preferred qualifications on this apparatus. Any exceptions from the preferred qualifications will require an in-depth explanation of the manufacturer's intent and purpose.
- B. Any other items or options that the manufacturer deems necessary, relevant or advantageous to this apparatus can be submitted with the proposal. These items should be listed with the price of the proposed item on a separate page(s) under the header "Additional Provisions." The County reserves the right to select one (1), some or none of the options identified.

The manufacturer shall provide loose equipment only when specified by the County. Proposals shall only be considered from companies that have an established reputation in the field of fire apparatus construction and have been in business for a minimum of 20 years. Further, bidder shall maintain dedicated service facilities for the repair and service of products. Evidence of such a facility shall be included in bidder proposal.

Each bidder shall furnish satisfactory evidence of their ability to construct the apparatus specified and shall state the state and location of the factory where the apparatus is to be built. The bidder shall also show that the company is in position to render prompt service and to furnish replacement parts.

Proposers shall also indicate in the "Yes/No" column if their proposal complies on each item (paragraph) specified. Exceptions shall be allowed if they are equal to or superior to that specified and provided they are listed and fully explained on a separate page.
