

NOTICE TO BIDDERS

NOTICE IS HEREBY GIVEN that sealed proposals for construction work in SEDGWICK COUNTY, State of Kansas, said work known as Sedgwick County Project 803-M-3666; Bridge on 135th St. West between 21st & 29th Streets North (B474) will be received at the Sedgwick County Purchasing Office, 525 N. Main, Room 823, Wichita, Kansas, 67203, until 1:45 p.m., Central Time, Tuesday, March 29, 2016, and then publicly opened at 2:00 p.m. at the Requests for Quotation/Proposal Meeting. Recommendations for purchase will be made the following Thursday at 10:00 a.m. at the Board of Bids and Contracts Meeting. The project to be constructed or improved is approximately 585 feet and is briefly described as follows (the "Project"):

54'-72'-54' RCSH Bridge, Grading, Surfacing (Asphalt),
Seeding, Signing, Guardrail and Pavement Marking

Proposals must be accompanied by a certified or cashier's check, or bid bond with a Surety licensed in the State of Kansas and acceptable to the County Clerk in an amount to be at least five percent (5%) of the proposal. Checks to be made payable to the County Clerk of Sedgwick County, Kansas, and drawn on a solvent Kansas Bank. These checks are to be retained by the County Clerk until the contract for the project shall have been awarded and are a guarantee that if awarded the contract, the bidder will enter a contract and give bonds as required.

PROPOSAL

1. The undersigned bidder (the "Bidder"), proposes to furnish all materials, labor, supplies, equipment and incidentals necessary to construct Sedgwick County Project No. 803-M-3666; Bridge on 135th St. West between 21st & 29th Streets North (B474) in accordance with the Contract Documents.

2. If this Proposal is accepted, Bidder agrees to execute and deliver to County a contract in accordance with the Contract Documents and within ten days of notice of the award to Bidder. Bidder agrees that the bid deposit given concurrently herewith shall become the property of County in the event Bidder fails to execute and deliver such contract within said time. In the further event of such failure, Bidder shall be liable for County's actual damages that exceed the amount of the bid deposit.

3. The Notice to Proceed shall be issued no sooner than May 9, 2016, but it shall be issued no later than September 6, 2016. Bidder agrees to complete the work according to the Contract Documents within one hundred five (105) working days.

4. Time is of the essence in the Bidder's performance. Bidder agrees that County's damages would be difficult or impossible to predict in the event of a default in the performance hereof; and it is therefore agreed that if Bidder defaults in the performance of the Contract Documents, Bidder shall be liable for payment of the sums stipulated in the Contract Documents as liquidated damages, and not as a penalty.

5. Bidder hereby certifies that it has carefully examined all of the Contract Documents for the Project, that it has inspected the location of the Project and understands the nature and scope of the work to be done; and that this Proposal is based on the terms, conditions, and requirements of the Contract Documents. Bidder agrees that the performance time specified is a reasonable time, having carefully considered the nature and scope of the Project as aforesaid.

6. Bidder's proposed sureties and insurers are subject to the approval of County.

7. Bidder certifies that this Proposal is submitted without collusion, fraud or misrepresentation as to other Bidders, so that all bids for the Project will result from free, open and competitive bidding among all Bidders.
