On the recommendation of Kimberly Evans, on behalf of various county departments, Jennifer Dombaugh moved to **accept Acme Lithographers, Inc. and establish contract pricing for three (3) years with two (2) one (1) year options to renew.** This motion. The motion passed unanimously.

This recommendation was brought before the Board of Bids and Contracts and approved by the Commission on August 21. Acme Communications, Inc. was originally awarded the contract, then informed the county that they would not be able to fulfill the contract as they are unable to locate replacement parts for the necessary equipment. They also indicated that they do not have properly trained personnel that is needed. The county's Legal Department has reviewed the issue, and advised Purchasing that the next price award.

Acme Lithographers is the current vendor providing these services. Annual spend for 2012 was \$55,187.02.
