On the recommendation of Gunda Angelica, on behalf of Emergency Medical Services and Fleet Management, David Spears moved to accept the proposal from Halcore Group Inc., dba American Emergency Vehicles (AEV) at contracted rates listed above for the chassis current model year, with a not to exceed 3% increase for subsequent model years on conversion and components for a contract period of three (3) years. Tim Kaufman seconded the motion. The motion passed unanimously.

Responses were evaluated based on meeting qualifications outlined in the RFP, specifications, references, cost and overall approach to the project. Experience with AEV's new ambulances has proven to be of exceptional quality when compared to prior ambulance purchases.

The county's purchase of new AEV ambulances was for \$164,972.00 each. The price of a current model year remounted ambulance through AEV is estimated at \$107,683.00, which is a savings of over \$57,000.00 per ambulance. Possible combined trips for pre-build and final inspection to the manufacturing facility for both new and remount purchases would result in additional savings to Sedgwick County Emergency Medical Services.

Ford QVM (Qualified Vehicle Modifier) Program is Ford Motor Company's quality recognition given to aftermarket adaptive equipment installers that meet manufacturing "best practice" guidelines. Ford Motor Company developed the QVM program to assist builders in achieving greater levels of customer satisfaction and product acceptance through the manufacturing of high quality conversion vehicles. To qualify as a QVM, a modifier must be successfully evaluated by Ford Motor Company on criteria such as engineering, the manufacturing process, quality control and adherence to Ford guidelines.
