On the recommendation of Kara Kingsley, on behalf of the Division of Finance, David Spears moved to accept the best proposal from Banc of America Merchant Services, LLC, dba Bank of America Merchant Services (BOA), establish contract pricing on the rates listed above and execute a three (3) year contract, with two (2) one (1) year options to renew. Tim Kaufman seconded the motion. The motion passed unanimously.

A review committee comprised of Greg Gann, Greg Faber-DIO, Jeremy Gibbs, Nancy Rausch, Debbie Rogers-Treasurer's Office, Sara Jantz, Brandi Bailey-Finance and Kara Kingsley-Purchasing, evaluated all proposals, shortlisted and interviewed four vendors (BOA, Forte Payment Systems, Inc., Acumen Business Connections, Inc., and Kubra Data Transfer, Ltd.) and agreed that BOA has the best approach to address the County's needs. The services offered are user-friendly, have the greatest flexibility and reporting capabilities and are cost efficient. In addition, references were contacted and each reported a high level of satisfaction with their services. BOA currently holds the State of Kansas contract for credit card acceptance program and lease equipment purchase.

Merchant Services allow constituents the ability to make payments for Sedgwick County services via over-the-counter credit/debit card, internet check or internet credit/debit card transactions. The proposal as chosen will offer a new service, Interactive Voice Response (IVR). IVR will allow constituents the option to make payments via telephone.

*Price will also include Interchange Fees. Each Interchange level has an associated Interchange Fee that is established by MasterCard, Visa and Discover Network. The amount of the Interchange Fee will depend on the type of transaction and the Interchange level at which the transaction is ultimately processed.
