Recommend the overall low bid from Certified Laboratories, a Division of NCH Corporation, to establish contract pricing for one (1) year, with a one (1) year option to renew; not to exceed \$25,000 annually.

On May 9, 2014, the contract with Thomas Archuleta dba Dr. Fuel Good was canceled; bid did not meet specifications. New contract was awarded to Certified Laboratories, a Division of NCH Corporation.

Last year, an estimated 400,000 gallons of fuel requiring diesel fuel additive and 15,000 gallons of fuel requiring fuel biocide was used. Vendor's ratio, price, and last year's estimated fuel quantities were used to estimate totals.

* Used highest price for possible increase (< 1 year price + 10%).

** Vendor's offer includes 1 quart of Tank Tonic (fuel biocide product) for every 5 gallons of Diesel Mate (diesel fuel additive) purchased, resulting in no charge for the Fuel Biocide Product.
