On recommendation of Josh Lauber, on behalf of Public Works, Richard Powell moved to **accept the low bid meeting specifications from H. Excavating, LLC for an initial purchase in the amount of \$52,300.00 and establish contract pricing for two (2) years with three (3) one (1) year options to renew.** Linda Kizzire seconded the motion. This motion passed unanimously.

Stone for aggregate ditch lining is a 5" rip rap rock material used to prevent washouts around reinforced concrete box (RCB) projects. The bid from H. Excavating, LLC represents a 2.61% price decrease from the last contract established in 2015.

Note:

South West Butler Quarry, LLC provided a bid with commodity price of \$11.00/ton only and does not deliver. South West Butler Quarry, LLC provided Bannon Trucking company that Sedgwick County would be required to coordinate with to deliver commodity for \$6.25/ton instead of the award winner. The bid also does not meet KDOT specs of 3X6 rip rap.

On recommendation of Britt Rosencutter, on behalf of Fleet Management and Public Works, Richard Powell moved to **accept the proposal from Truck Center Companies - Freightliner & Fleet Pride in the amount of \$561,825.00 and establish contract pricing for Non-Warranty items for 3 years at the rates listed above.** Linda Kizzire seconded the motion. This motion passed unanimously.

An evaluation committee comprised of Penny Poland and Robert Austin - Fleet Management, Jon Medlam - Public Works, Brian Richey - Fire, and Britt Rosencutter - Purchasing, evaluated the proposals based on the criteria set forth in the RFP. The committee unanimously agreed to accept the proposal from Truck Center Companies - Freightliner & Fleet Pride.

These trucks are used to haul a variety of items and are used daily. They haul materials to job sites on the roadways, bridge projects, and stream maintenance. Materials like sand, asphalt, dirt, rock for rock shouldering projects, rip-rap around bridges and streams, chip rock for roadway scrub seal and other items that need to be hauled to project sites. They also haul trees and debris from streams and bridges. They are also utilized in the event of a natural disaster. The trucks will also have spreaders and plows put on them to be used during snow and ice operations, and spray tanks to anti-ice before a snow event.

Tim Kaufman: Could you give me a frame of reference, what percentage of the overall dump truck fleet is this?

Penny Poland: There are 22 in Public Works that are dispersed through their yards.

Tim Kaufman: Okay, is this pretty typical. Are you replacing 3 every couple of years?

Penny Poland: The reason that we are requesting the replacement of this vehicles is because of how this vehicle is used to transport inmates throughout the state. We do not want it to have a mechanical failure when it's out on the road. We had one that was just at 200,000 and we had a transmission failure just near Hays. It had inmates in the vehicle, so we had to coordinate with the Sheriff and an outside vendor to replace that transmission. We want to keep those miles down. By the time this vehicle is replaced it will have about 180,000 on it.

Tim Kaufman: Okay, so I think that this is a good example of the time that we've got the 15 point benchmark, but we also use your professional judgement as well.

Penny Poland: That is correct.
