- All school districts in Kansas had opportunity to apply for grant funding to implement School Mental Health Pilots with funding that came from cost savings this past year. Applications were due June 14, 2019. Current sites could also apply to support more schools. USD 259 submitted an expansion request for two schools and we know that Maize and Valley Center also applied. Others like the model but opted not to apply for grant funding.
- COMCARE has been informed that come July 1, 2019, persons who are in a detention center or state hospital will have their Medicaid restored on the date they are discharged. This will stop the process of terminating coverage and aid in sustaining medications and appointments post discharge.
- Netsmart (our new electronic health record vendor) was on site the week of June 10th where we reviewed the current build and work flows. This was a milestone event and we continue toward our January 1, 2020 go live date. Much still needs to occur, but we are making progress.
- COMCARE staff delivered Youth Mental Health First Aid and ASSIST training as well as several presentations about COMCARE services to the community.
- COMCARE is partnering with the Office of the Medical Director (OMD), WPD, Sherriff's
 Office, EMS, Sedgwick County Fire and WFD on a paramedicine project. ICT-1 is a proof
 of concept pilot that will launch in August for four months in which a special van will
 respond to certain 911 calls that have a likely mental health component. On the van will



be a paramedic, law enforcement officer and a COMCARE clinician. Goal is to provide care in place and reduce the non-emergent call load to fire and law enforcement.

- During the month of June, Sedgwick County Developmental Disability Organization (SCDDO)
 Quality Assurance Staff completed 3 day and 12 residential program visits.
- On Friday June 7, 2019 the SCDDO's Behavioral Health Advisory Workgroup hosted a Meet and Mingle Event at Heroes Bar and Grill in Old Town. Both IDD and Behavioral Health professionals were able to get together, meet one another, and discuss important topics related to dual diagnosis and the two service systems. Approximately 50 people attended and enjoyed food, drinks and good conversation. Contact information was exchanged in an effort to promote communication between the intellectual/developmental disabilities (IDD) and mental health professionals to better serve those with co-occurring disorders.
- The Sedgwick County Business Leadership Network (BLN) hosted its annual meeting June 27
 at Botanica. Around 30 folks enjoyed hors d'oeuvre, learned more about the BLN and its
 successes over the last year. Attendees also participated in a short experimental activity
 designed to increase understanding of mental illness in the workplace led by Dr. Jennifer
 Stone with Wichita State University.
- As part of a capacity building grant, Disability Cocoon hosted an online "Tech: Solutions Intro." The event focused on the potential enabling technologies have to transform how

disability supports are defined and to reduce the reliance on scarce direct support (human) resources. The event acted as a one-day, online crash course on all things disability technology. The next step is for Disability Cocoon to begin in-person meetings with the four interested affiliates to determine what technologies would work best for them. The grant will cover the cost of the purchase and implementation of these technologies for the affiliates.

Health Department*

- Epidemiology:
 - On June 2, one Epidemiology staff member presented a poster titled, "Elevated Blood Lead Priority Mapping to Improve Lead Poisoning Outreach and Case Ascertainment in Sedgwick County, Kansas," at the Council of State and Territorial Epidemiologists (CSTE) Annual Conference. The poster was selected as a finalist for the CSTE conference in the Environmental Health conference track based on the submitted abstract.
 - One Epidemiology staff attended the Southeast Center for Excellence in Vectorborne Diseases Tick Surveillance and Identification Workshop at Hobbs State Park, Arkansas. The workshop brought together public health professionals from five states and the Centers for Disease Control and Prevention to learn about ticks, tickborne diseases, and conducting tick surveillance. Participants attended lectures and practiced tick surveillance and identifications.
- Immunizations: The immunization program partnered with Sedgwick County EMS to vaccinate first responders with state funded Tdap for disaster relief vaccine. During the month on June,39 first responders received the state funded Tdap vaccine due to anticipated flooding. Mobile clinics were held at various locations to ensure the vaccine was available to all first responders. Preventive Health Division staff attended the 2019 Kansas Immunization Conference where they received the latest updates on immunization best practices.
- Women, Infants and Children (WIC): 2,596 women, 2,706 infants, and 6,553 children under age five a total of 11,855 enrolled in the SG County WIC Program.








