RE: Year 5 (2019) Compensation for Inmate Healthcare Services Agreement

Dear Colonel White,

I hope this letter finds you well. Wellpath LLC fka Correct Care Solutions, LLC ("CCS") is proud to partner with Sedgwick County, and aims to surpass your needs concerning the level and quality of services we provide.

Per Section 1 of Appendix C of our Agreement, for Year 5 (2019), the monthly price shall increase based on the Consumer Price Index ("CPI") for Urban Consumers – US City Average for Medical Care Services Component for the 12-month period ending on November 2018, which stands at 2.4%. Additionally, 40 hours (1.0 FTE) of RN, to cover the annex, was added February 1, 2019.

Application of these increases, revises the base amount from **\$481,875.46** monthly to **\$493,440.47** monthly, retroactive for the month of January 2019. The addition of the nursing hours, increases compensation to **\$501,871.05** monthly, effective February 1, 2019 through December 31, 2019.
