**A RESOLUTION MODIFYING CHAPTER 16 OF THE *SEDGWICK COUNTY CODE* REGARDING INMATE GRIEVANCE PROCEDURES BY RESCINDING SEDGWICK COUNTY RESOLUTION NO. 135-2005.**

**WHEREAS**, the Board of County Commissioners established an Inmate Administrative Claim Procedure pursuant to Resolution No. 135-2005 on August 24, 2005; and

**WHEREAS**, on October 1, 2019, Sedgwick County Sheriff Jeffrey T. Easter issued General Order No. 107.11 establishing updated inmate grievance procedures for the Sedgwick County Detention Facility in accordance with current state and federal law; and

**WHEREAS**, in consideration of General Order 107.11, and with the goals of reducing duplication of process and fostering efficiency and clarity, the County's Inmate Administrative Claim Procedure need no longer be used; and

**WHEREAS**, the Board of County Commissioners believes it would be appropriate to rescind Resolution No. 135-2005.

**NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, AMENDS THE *SEDGWICK COUNTY CODE* AS FOLLOWS:**

**SECTION 1. SEDGWICK COUNTY RESOLUTION NO. 135-2005 IS RESCINDED.**

Sedgwick County Resolution No. 135-2005 is hereby rescinded. Accordingly, Chapter 16, Article IV of the *Sedgwick County Code* is also rescinded.

**SECTION 2. PUBLICATION AND EFFECTIVE DATE.**

Upon the adoption of this Resolution, the Clerk of Sedgwick County shall publish this Resolution once in the official County newspaper and it shall become effective upon publication.

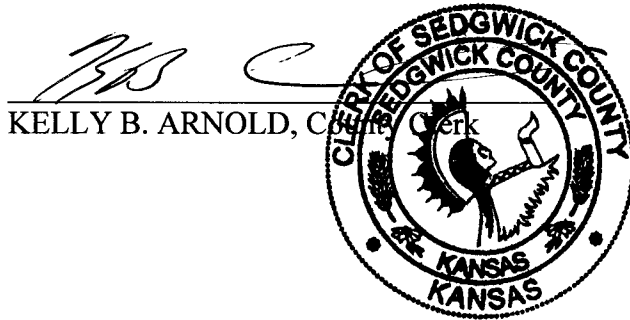
