On the recommendation of Lee Barrier, on behalf of various county departments, Jennifer Blasi moved to accept the proposal from Galls, LLC (Galls) based on the BuyBoard Cooperative Purchasing contract #587-19 and establish contract rates listed above through May 31, 2022. Linda Kizzire seconded the motion. The vote passed four to one with Tim Myers abstaining from the vote.

Galls was unanimously selected to provide service for Sedgwick County in 2016 and has been supplying uniforms and related items for various county departments for the past three (3) years.

Galls' website has streamlined the ordering process for the various departments by offering 24 hour service, 7 days a week. The website is compatible with mobile devices allowing employees who work varied schedules to place orders at their convenience. The website also grants administrative access that allows designated employees to add/delete users, pull reports, view invoices and credit memos. All orders can be tracked in real time.

In addition Galls has opened a local service center that is a hub for public service employees to place orders, pick up orders, have items altered, and receive fittings.

Utilizing the Buyboard Cooperative Purchasing contract that is already in place allows Sedgwick County to retain a successful vendor and its collaborative processes.

### **Questions and Answers**

Russell Leeds: Do we have questions from the Board on this item?

Tim Myers: What has been our experience dealing with Galls?

Col. David Mattingly: Our experience with Galls has been very positive. The ordering method is very easy, but more importantly the backend management of the system is very helpful for our Quarter Master position. They can put in expiration dates for items such as body armor. So we can order in advance before expiration occurs. We can see what everyone has been issued?

Russell Leeds: Based on the current contract and with the proposal to accept the BuyBoard Cooperative pricing is a 15% off catalog price comparable or less than what we're paying currently?

Joe Thomas: It's very comparable there are a few items that have had minimal increase.

Russell Leeds: Other questions from the Board? The BuyBoard Cooperative could you talk briefly about their process?

Joe Thomas: Yes, the cooperative process is where they look for a public agency to drive the actual proposal. So they will advertise that there is a bid coming out. They will gather all the bids, score them like we do in our normal process, they will shortlist the vendors and then they will make a select. So it really mirrors the same process that we use.

Russell Leeds: Okay. The cooperative is a representative of governmental entities?

Joe Thomas: Yes, sir.

On the recommendation of Josh Lauber, on behalf of Facilities Maintenance Tim Myers moved to accept the proposal from Otis Elevator Company in the amount of \$73, 800.00 annually and establish contract rates for three (3) years with two (2) one (1) year options to renew. A review committee comprised of Andrew Dilts, David Perricone, and Kendal Ewing - Facilities Maintenance; Clark Wiemeyer - Courthouse Police; and Josh Lauber - Purchasing, evaluated all proposals based on the selection criteria outlined in the RFP. The decision to recommend Otis Elevator Company was reached unanimously based on being the low proposal and not having a contractual elevator past due on their annual inspections. Jennifer Blasi seconded the motion. The motion passed unanimously.

The objective of having an on-call elevator contractor is to acquire long term comprehensive elevator maintenance and repair services with a vendor that has the experience and qualifications to identify and correct potential problems. The on-call vendor's responsibility is to ensure county elevators are in compliance with Metropolitan Area Building and Construction Department (MABCD) codes.

Proposals were received from four (4) vendors. Only two vendors (Otis & Thyssenkrupp) provided proposals that met the RFP requirements.

Notes:

A brief overview of the proposals received are below:

\*Boesen Plumb Elevator Solutions - excludes hydraulic units located underground and MCH lobby elevator machine components.

\*\*Kone, Inc. - excludes insurance requirements, indemnification requirements, performing background checks, motor generators, guide rails, cab communication devices, hydraulic units located underground, etc.

\*\*\*Thyssenkrupp Elevator (alternate proposal for \$101,232.00) - requested 90 days to assemble a CIP for repairs that would be reviewed and agreed upon with the county, reduce preventative maintenance frequency to 1 hour each quarter instead of 1 hour each month.

#### Questions and Answers

Russell Leeds: Questions from the Board on this item?

Tim Myer: What has been our experience dealing with Otis Elevator Company (Otis) for the county?

Andrew Dilts: We do not have any experience with Otis themselves. We do have some experience with the other vendors that submitted proposals. However, Thyssenkrupp Elevator is the only other vendor that submitted a proposal that met the RFP requirements and we have reason to believe that Otis would be a better provider for us.

Tim Myers: I noticed looking at the bid we're looking at for example one in the area of \$3,600.00 and then you're looking at for the same service around \$7,200.00. So basically twice as much.

Andrew Dilts: I'm sorry, could you clarify where you're seeing that example.

Tim Myers: #1 PSG TR, we're looking at Otis compared to the other at \$7,200.00.

Andrew Dilts: Otis, we have a lot of their components here at the Main Courthouse as well as at other facilities. Since this equipment is proprietary they can get those parts at a lesser cost then what they're going to sell to the other vendors. So that is one advantage Otis has over the other vendors as far as how much equipment that we have that is proprietary to them and the expense of the parts that they sell to the other vendors. There is a markup. We asked a question to all the vendors, as far as to how they maintain all of their elevators and stay in compliance with MABCD. Otis was the only one that didn't have any red flags that came up.
