## **Questions and Answers**

Tim Myers: Is the pricing per case pretty close to what it was on our last contract?

Anna Meyerhoff: No. Paper, within the market, has had a lot of volatility in the last several years. Our last contract was actually terminated because of what was happening in the market and the vendor could no longer adhere to the prices of the contract. Our last contract was done in 2017. From then to now on average for the stock on the contract is a 17% increase.

Russell Leeds: Are we currently contracted with Timber Creek?

Anna Meyerhoff: We are not. They were our last contract but they were the ones who terminated but they will be able to do this contract for a year term.
