A review committee consisting of Tabitha Lehman, Melissa Schnieders, Sandra Gritz - Election Office; Ronny Tidwell - Appraiser's Office; Bobbi Meairs -Division of Information & Technology; and Josh Lauber - Purchasing evaluated all proposals and unanimously selected EasyVote Solutions, Inc.

As the complexity of election administration continues to increase and the number of registered voters in Sedgwick County continues to rise, it has become necessary for the Sedgwick County Election Office to increase our efficiency during peak election cycles. At the same time, the security of elections has become a priority, with elections being designated as part of the nation's critical infrastructure. The purchase of election management software will provide an efficient means for this office to implement continuity of service protocols and plan future staffing needs, strengthen our chain of custody procedures, and recruit and retain election poll workers. We are now faced with a Presidential election cycle which is predicted to have record breaking voting turnout and complexities the likes of which this office has never before encountered, and find that this is an optimal time to acquire and implement Election Management Software.
