The personal protective equipment (PPE) for this bid contract includes the following structural firefighting accessories: structural protective boots, gloves, helmets, and hoods. These items are designed to be worn in conjunction with structural firefighting coat and pants to provide firefighters with the maximum protection against heat and particulates per NFPA 1971 standards. These items are in constant need of replacement during the course of a firefighter's career due to normal wear and tear and useful life expectancy of the PPE.

Note:

Sedgwick County Fire District #1 has worked with each of these vendors in the past and they continue to provide our organization with the most current safety equipment to keep our firefighters as safe as possible.

The annual expected cost of these replacement PPE accessories is between \$39,000.00-\$50,000.00.
