COVID question for Commission Meeting

Comment:

“Commissioner,

My question. Can the commission define the threshold for being in an epidemic? And has the commission verified that Sedgwick County and/or Kansas even qualifies as being in an epidemic?

I was doing some of my own research the other day, and I came across information I had never seen it heard before. Lacey Cruse asked a question that, although she did so with a different outlook, was a very good one.

What is the threshold (in her words, how many deaths) before we require masks?

So, I researched this.

Of course, anyone who isn't making "cases" equivalent to deaths, knows that deaths have been declining since April, even though we opened up.

However, just to stick with the facts:

The CDC standard for defining an epidemic for both pneumonia and influenza appears to be when 5.9% of deaths are caused by either illness.

The death rate in Kansas in 2018 (I'm sure there's more recent, but it was pretty much the same as previous years and is likely a good average) was 27,213.

If you divide this by 365, you get 75 averagee deaths per day in Kansas.

If you take this number multiplied by 5.9%, you get the CDC pneumonia and influenza threshold for defining an epidemic.

This number is 4.4

So Kansas would have to have more than 4 deaths in average per day to even define us as being in an epidemic (the CDC measures averages over the course of the week, because our pneumonia/influenza numbers just skyrocketed--likely because of the shutdown, and they wanted to be clear that we are not in another epidemic).

On May 11, Kansas had 6 deaths. Since then, only twice have we barely exceeded 4.

Somebody else can add up each day's count and divide it out to find the exact average, but it appears the average number of daily

deaths in Kansas since May 11th is 2. We could double the average number of deaths and still not be "epidemic."

Of course, we don't want to double our numbers, but we've been open a month and numbers are staying low.

This hysteria is political, not science.

This quote is often shortened/paraphrased to a condensed version: "Those who would trade liberty for safety deserve neither."

In an American context, Franklin's line plays on the idea that liberty is the thing we would be protecting by choosing safety. In opting to give up liberty in favor of safety, we are essentially gaining nothing.

The thing we value most (liberty) is lost if we elevate safety to a place of primary value. The essence of this idea, to me, is that liberty entails some necessary degree of uncertainty. Liberty stands in opposition to tyranny, to paranoia and to knee-jerk militarism.

When people have liberty (freedom of choice, freedom of speech, freedom of action, freedom of movement, etc.), they are not being controlled and so might go "out of control" and use that liberty to harm others. If a position was adopted that sought to curb liberty so that people would or could not go "out of control" then people would effectively be controlled. In opting for safety of this kind, freedom of movement, freedom of choice, freedom of speech and freedom of action would be reduced or eliminated.

"The overwhelming majority are younger, healthier people," Dr. Atlas said.

"It only matters if we cannot protect the high-risk people, which we are protecting ... how do I know? Because the death rates are not going up."
