Key Terms

- Distribution: Delivery of vaccine to entities that will provide vaccine to people.
 - · Role: Federal, state, and local health departments
- Dispensing: Providing vaccine to people.
 - Role: Hospital, health dept., clinics, others that meet criteria
- Allocation: Determining which groups of people get vaccines and when, based on availability of vaccine.
 - Role: Federal and state health departments
- Prioritization: Determining the order in which people get vaccines within each phase of allocation, based on availability of vaccine.
 - Role: Local health officer's prioritization committee made up of local medical representatives



Part 1: What We Know

- Health Department has experience and training with large scale vaccination clinics (H1N1)
- A COVID-19 vaccine will arrive soon to community partners, Health Department not in initial round
- CDC will provide guidance to KDHE; KDHE may provide further guidance to Health Department
 - Systems are in place to track vaccine and PPE entrusted to County (within Health and Emergency Management)

Health Department Roles

- Vaccine Distribution
 - Provide the vaccine for partners to administer
 - Vaccine may go to other entities before Health Department
- Vaccine Dispensing
 - Administer the vaccine to community (clinic, mobile sites)
- Data Collection & Reporting
 - Collect and report all information as required by CDC

Planning Timeline

Late June	Internal vaccine planning team holds first meeting

Health Department holds vaccine planning exercise September

October Dr. Minns hosts initial prioritization conversation

November Health Department completes first draft of local COVID-

19 vaccination plan; Minns' group reconvenes; orders ultra-cold freezers

Minns' group meets again; finalizes local plan; expects December first round of doses



Part 2: Challenges

- Changing landscape (i.e. vaccine approval, number of doses, distribution process)
- Logistics of cold storage requirements that differ between companies
- State agencies trying to keep up with changes lead to less communication with local agencies
- State agencies working directly with multiple entities in the county
 - Information discrepancies between different levels of government
