On the recommendation of Josh Lauber, on behalf of the Regional Forensic Science Center, Tim Myers moved to **accept the quote from NicheVision Forensics, LLC in the amount of \$88,815.00 for a contract period of five (5) years.** Anna Meyerhoff seconded the motion. The motion passed unanimously.

Sedgwick County's forensic DNA laboratory continues to experience an increase in demand for "touch" DNA analysis of items where a limited amount of DNA is present and where the detection of multiple contributors is expected.

Over the last five (5) years, the FBI's DNA Advisory Board, the European Network of Forensic Science Institutes, the Scientific Working Group for DNA Analysis Methods, and the United States Department of Justice have all recommended the use of probabilistic genotyping methods for the interpretation of mixture profiles.

In order to stay abreast with the technical advances in forensic DNA analysis, the forensic DNA laboratory purchased STRmix probabilistic genotyping software. The RFSC has leveraged a substantial amount of grant funding to purchase the STRmix software, to provide users with training, and to obtain technical support required for validation studies. The software is critical in the evaluation of DNA profiles and the information derived from the software is used for DNA reporting and court testimony.

NicheVision Forensics, LLC is the exclusive US distributor for the STRmix probabilistic genotyping system and support and continuity of operations depends on ongoing upgrades and maintenance.

On the recommendation of Josh Lauber, on behalf of the Metropolitan Area Building and Construction Department, Anna Meyerhoff moved to **accept the quote from Avolve Software Corp. in the amount of \$147,265.45 good through April 24, 2026.** Tim Myers seconded the motion. The motion passed unanimously.

The MABCD is responsible for monitoring all building code compliance concerning residential and commercial structures built or remodeled within unincorporated Sedgwick County, the City of Wichita, and nine (9) other class two (2) & three (3) cities within the county. Multiple sets of plans are submitted to the MABCD for review, and when corrections are necessary the plans must be noted and returned to the design professionals for adjustments and then resubmitted. Once plans are approved, they must be picked up from the MABCD and one (1) set of plans is retained by MABCD for their records.

Electronic Plan Review (EPR) software automates the above process and creates efficiencies including reducing paper, saving trips to and from the MABCD, enhancing communications between architects and plan examiners, creating better security measures, and reducing retention and scanning costs for the MABCD.

In 2015, Request for Proposal #15-0050 yielded an award and recommendation to Avolve Software Corp.

In 2020, the county paid \$28,875.58.

Questions and Answers

Anna Meyerhoff: We acquired this software in 2015. We have already had it for five (5) to six (6) years and we are entering into another contract to take it to almost ten (10) years of having this software. Are we going to want it that long?

Chris Labrum: We will. If we decided to switch platforms, we would be able to in the contract. The Projectdox is our software provider for electronic plans starting in January of 2019. All plans must be submitted electronically. This is the standing service contract we've had for the first five (5) years. We are opting to renew and stay with them. It's a very stable platform, easy to maintain, and fairly cost effective. Right now we pay just shy of \$29,000.00 a year in maintenance fees. This bounces it up \$600.00. We are in the process of contracting to upgrade the system. This service contract accommodates all of that. They will provide the same service for any upgrade or additions we make to the software.

Tim Myers: You guys have been happy with the way that has performed?

Chris Labrum: We have, yes. At the moment we have no intentions to change. Even if we decided today that we wanted to switch platforms, it would probably take us five (5) years to come off of this platform and have a new one in place.

Tim Myers: Like you said, we are only looking at a \$600.00 increase on what we spent last year?

Chris Labrum: Right, a yearly increase over the last five. They have been very good to work with.

Russell Leeds: This process is all revenue generating and pays for itself?

Chris Labrum: And some, yes that is correct.
