The staff was fantastic when they heard what happened and moved us closer to the front. We left at 1:30, 10 minutes ahead of the 15 minutes wait time. I just wanted to get her home.

At the same time, my wife, a cousin, and friend drove out of state to receive their 65+ 1<sup>st</sup> vaccine, by the way, ahead of schedule and was also scheduled for their 2<sup>nd</sup> shot at the same location. Other Kansas countries are 65+. What is missing here?”
