ADDENDUM 1 RFP #21-0002 CUSTODIAL SERVICES FOR THE SEDGWICK COUNTY CORRECTIONS

March 3, 2021

The following is to ensure that vendors have complete information prior to submitting a proposal. Here are some clarifications regarding the proposal to provide custodial services for Sedgwick County Corrections.

Questions and/or statements of clarification are in **bold** font, and answers to specific questions are *italicized*.

1. What type of flooring is at 905 N. Main?

Answer: The floors are mostly carpeted except for the bathrooms and breakrooms and a couple of hallways that are VCT tile. One stairway has rubber tile.

2. What time is cleaning to be performed at all of these locations?

Answer: All locations are to be cleaned after 5:00 P.M. daily Monday through Friday. Staff at Juvenile Field Services work a little later.

3. What type of flooring is at Drug Court and Juvenile Field Services in the Wichita Mall?

Answer: The floors are mostly carpeted except for the bathrooms and breakrooms and a couple of hallways that are VCT tile.

4. What type of flooring is at the Adult Residential Facility?

Answer: The floors are mostly carpeted except for the bathroom, breakrooms, common rooms, and hallways that are VCT tile.

5. How often are the carpets cleaned and the hard floors waxed and scrubbed?

Answer: Carpets are to be cleaned twice annually. Tile floors are to be stripped and waxed once annually and scrubbed and waxed once annually.

- 6. PLEASE NOTE: The custodial services at the Adult Residential Facility will cease when COVID restrictions are lifted.
- 7. PLEASE NOTE: There is a revised floor plan being sent with this addendum to highlight Drug Court.

Firms interested in submitting a proposal must respond with complete information and **deliver on or before 1:45 p.m.** CST, Tuesday, March 9, 2021. Late proposals will not be accepted and will not receive consideration for final award.
