#### Notes

The county has used this product since 2004 noted for its reliability and usefulness. It is used to stream live county BoCC meetings on Wednesday mornings with closed captioning and also is used to store videos for Board of Bids and Contracts meetings, BoCC staff meetings, any special meetings, and many department videos including Sheriff, Fire District 1, Emergency Management, and Human Resources to name a few.

The Sheriff's Office uses Granicus to store many of their training videos that are too big to store on their PowerDMS system. The county has various videos covering topics used by the jail for inmate information, LETC training, and other information to all the Sheriff employees.

Fire District 1 has many training and informational videos they use for employee education.

During COVID-19, Granicus was instrumental in getting COVID-19 training and information out to many departments about Personal Protective Equipment, how to stay safe around the public, and basic COVID-19 information.
