Question 1: Can you provide the last bid tab for Rock Salt and Liquid Calcium Chloride?

Answer: Calcium Chloride has not been formally bided in recent history due to the need not arising until recently.

Question 2: What were the renewal prices were for the prior two years?

Answer: The 2019-2020 renewal term agreed to a delivered price of \$40.75/ton. The 2020-2021 renewal term agreed to a delivered price of \$41.56/ton.

Question 3: Do you anticipate any prefill tons before next winter? If so, is there an estimated quantity and when do you think you would order?

Answer: No.

Question 4: Do you accept both end dumps and hoppers for delivery?

Answer: End dumps are preferred, hoppers are acceptable.
