On the recommendation of Jaimee Witmer, on behalf of COMCARE, Health Department, and other various departments Tim Myers moved to accept the proposal from Family Prescription Shop Inc. DBA Hart Pharmacy and establish contract pricing at the rates listed above for (1) year with four (4) one (1) year options to renew. Linda Kizzire seconded the motion. The motion passed unanimously.

A committee comprised of Itress Tackett, David Marrs, Rex Lear, and Mary Mahurin - COMCARE; Maihoa Nguyen and Brad Ashens - Health Department; and Jaimee Witmer - Purchasing evaluated all proposal responses based on the criteria set forth in the RFP. The committee unanimously agreed to accept the proposal from Family Prescription Shop Inc. DBA Hart Pharmacy.

COMCARE of Sedgwick County currently utilizes a pharmacy that is co-located in the same building as the Adult Medical program and has four (4) programs that benefit from pharmacy services which are: Adult Medical Services located at 1919 N. Amidon, Community Crisis Center (CCC) located at 635 N. Main, Children's Services (CS) located at 350 S. Broadway, and Center City (CC) located at 402 E. 2nd. These pharmacy services include providing pre-packaged medications for identified COMCARE clients, administering Patient Assistance Program (PAP) for all necessary medications, billing Medicaid and other HMOs/insurance companies for prescription costs, medication delivery, utilizing an ePrescribe system, handling all refill requests, etc.

The Health Department (HD) relies on this service to conduct quarterly audits of HD programs' medication dispensing procedure(s) to assure the county's compliance with Kansas Administrative Regulations and State Statutes (K.A.R. 68-7-18 and K.S.A. 65-1648), perform annual renewal of pharmacy licenses of each County HD locations of services, evaluate and assess programs' policy and procedure compliance, schedule and perform emergency pre-packaged medication check outside of the quarterly audit time when needed, and provide pharmacy consultation to HD staff when needed.
