On behalf of Project Services, Tim Myers moved to accept the low bid from Snodgrass & Sons Construction Co., Inc. in the amount of \$623,450.00. Linda Kizzire seconded the motion. The motion passed unanimously.

In order to safely facilitate the repairs to the Tropics Exhibit Roof, the majority of the animal residents must be relocated to alternative housing. Currently the Sedgwick County Zoo has no additional alternative space that meets the husbandry needs of the residents of the Tropics. This proposed building will enable the Zoo to adequately house and care for the Tropics' residents during the roof replacement and provide a usable space for future need for alternative housing for multiple zoo species.

#### **Questions and Answers**

Linda Kizzire: What kind of animals are housed in the Tropics?

Scott Newland: Currently in the Tropics, the majority of our residents are primarily birds and we have a small bat colony. We also have a large resident population of tropical fish. The fish we have housing for but the birds and the bats we do not have another adequate facility. Which is why we have asked for this building.
