FEDERAL Departments & Agencies

Federal Communications Commission (FCC) - Emergency Broadband Benefit - \$50 for one month internet service, \$100 to purchase computer equipment for low-income households - www.fcc.gov

Federal Emergency Management Agency (FEMA) - Funeral Assistance Program to Individuals – up to \$9,000 for COVID-19 related deaths- application must be initiated by <u>phone call</u> to FEMA - **Funeral Assistance FAQ** | **FEMA.gov.**

FEMA will continue to reimburse state, local, tribal and territorial governments for the use of their National Guard to respond to COVID-19 at a 100% cost share until **Sept. 30, 2021.**

FEMA will continue reimbursement for eligible emergency work projects as appropriate and consistent with applicable law, including lease of space/equipment to administer/store vaccines, additional staffing/training, additional PPE & technology to track vaccines/rates - www.fema.gov.

Small Business Administration (SBA)-\$15 Billion for Economic Injury Disaster Loans (EIDL) and \$5 Billion for EIDL Advance Program support- www.sba.gov.

U.S. Economic Development Administration (EDA) – Build Back Better Regional Challenge – Phase 1 - Up to \$500,000 in technical assistance to regional coalitions to develop/support 3-8 regional growth cluster projects **DEADLINE Oc. 19, 2021**. Phase 2 – Up to \$100 million to coalitions to implement proposed projects **DEADLINE March 22, 2022** – **www.eda.gov.**

U.S. Department of Agriculture (USDA) - Coronavirus Food Assistance Program (CFAFP) for producers DEADLINE Oct. 12, 2021. Pandemic Assistance for Timber Harvesters & Haulers (PATHH) DEADLINE Oct. 15, 2021.

U.S. Department of Education (DOE) - \$767.3 Million to Higher Education Emergency Relief Fund(HEERF)- Minority Serving Institutions-**DEADLINE Oct. 1, 2021**.

\$421.6 Million to Higher Education Emergency Relief Fund (HEEFR) Strengthening Institutions Program – **DEADLINE Oct. 1, 2021**. **www.ed.gov.**

U.S. Dept. of Health & Human Services (HHS) - \$10 Million Maternal, Infant & Early Childhood Home Vitiation Programs (open to states only) - DEADLINE Nov. 26, 2021.

\$12 Million Maternal, Infant & Early Childhood Home Visitation Program Continuation Funding (open to states only) - **DEADLINE Nov. 26**, **2021** - **www.hhs.gov**.

U.S. Department of Treasury/IRS - Federal tax on first \$10,200 unemployment comp received in 2021 waived - Ends Dec. 31, 2021. Advance of 2021 Child Tax Credit - \$3,600/child under age 6, \$3,000/child age 7-19 - Ends Dec. 31, 2021.

Small Business Employee Retention Tax Credit – up to \$28,000/employee - Ends Dec. 31, 2021.

Small Business Employee Paid Leave Credit – dollar for dollar payroll tax expense for employees with COVID-19 sick leave or quarantine - Ends Dec. 31, 2021.

Payroll Tax Deferral - employers and self-employed individuals can defer payment of the employer share of the Social Security tax they otherwise are responsible for paying to the federal government with respect to their employees. The deferred employment tax can be paid over the next two years—with half of the required amount to be paid by **December 31**, **2021** and the other half by **December 31**, **2022**. **www.home.treasury.gov.**

U.S. Department of Veterans Affairs (VA) - \$75.0 Million for Transitional Housing for Homeless Veterans - DEADLINE Dec. 6, 2021. www.va.gov.

Department of Children & Families (DCF) - Hero Relief Fund – assistance to working households under 250% FPL to help pay for licensed child care. **www.KSHeroRelief.com** - **https://dcf.ks.gov.**

Department of Health & Environment (KDHE) - \$50 million to KS hospitals to provide Premium Pay or other retention incentives for front-line nurses & care workers – DEADLINE Oct. 29, 2021 - https://kdheks.gov.

Increase the Reach Grant Program - \$10,000 - \$250,000 for community orgs & FQHCs to improve equity to access to vaccines in KS communities. Apply Online – **www.increasethereach.com**. First Round application period DEADLINE Oct. 15, 2021 – subsequent round deadlines will be announced quarterly.

Kansas Governor's Grant Programs - COVID-19 Pandemic Vaccination Equity Supplemental Funding (PAVE) Program – up to \$10,000 to local gov., non-profits, community orgs, medical providers/clinics, etc. for marketing, public education campaigns, conducting needs assessment focus groups, purchases vaccination supplies, provide transport assistance to persons seeking vaccinations (e.g. bus passes) and related personnel costs to complete activities. OPEN June 1 – Dec. 31, 2021. Apply Online – https://kansascovidgrants.com.

Kansas Housing Resource Corporation (KHRC) - \$ 200 million - The Kansas Emergency Rental Assistance (KERA) program, provides rent, utility, and internet assistance to households financially impacted by the COVID pandemic – apply online. \$56 million - Kansas Homeowner Assistance Fund (KHAF), to prevent mortgage delinquencies and defaults, foreclosures, loss of utilities and displacement of homeowners experiencing financial hardship because of COVID-19.
