QUITCLAIM DEED

THIS INDENTURE, Made this 5th day of February, 2021, between the City of Wichita, a municipal corporation, as Grantor, and the City of Wichita, a municipal corporation, as Grantee.

WITNESSETH:

That said party of the first part, in consideration of the sum of ONE DOLLAR, the receipt of which is hereby acknowledged, does by these presents, remise, release and quitclaim, unto said parties of the second part, their heirs and assigns, all the following described real estate situated in the City of Wichita, County of Sedgwick and State of Kansas, to-wit:

A portion of the unplatted land, lying East of the Big Arkansas River in the Northwest 1/4 SEC 18-27-1E lying South of the Big Arkansas River and lying North of the North line of Beal Avenue, now 11th Street extended west as platted in said Riverside Addition, Kansas except that part of Government Lot 1 in the Northwest 1/4 beginning at a point 876 FT West of the Northwest corner of Amidon Avenue and Beal Avenue, now 11th Street North; thence North 124.97 feet; thence Northeasterly 73.15 feet; thence Northeasterly 373.27 feet; thence Northeasterly 372.56 feet; thence Southeasterly 15 feet; thence Southwesterly 420.07 feet; thence Southwesterly 475.64 feet to the beginning, SEC 18-27-1E (Exempt 609-1) and except that part of Government Lot 1 in the Northwest 1/4 beginning West along said extended line 876 feet; thence Northeast 475.6 feet; thence Northeast 471.76 feet; thence Northeast to the East line of the Northwest 1/4; thence South 770 feet to beginning (a portion of current PIN 0019518) and

A portion of the unplatted land, lying East of the Big Arkansas River in the Northwest 1/4 SEC 18-27-1E lying South of the North line of Beal Avenue, now 11th Street extended west as platted in said Riverside Addition, Kansas and lying within 50 feet east of the established bank line of the Big Arkansas River and including any improvements lying largely within said tracts but extending beyond the eastern boundary as described, including but not limited to all pedestrian ways. (a portion of current PIN 00109518) and

A portion of the unplatted land, lying in the Southwest 1/4 LY North and East of the Big Arkansas River in SEC 18-27-1E and lying within 50 feet east of the established bank line of the Big Arkansas River and including any improvements lying largely within said tracts but extending beyond the eastern boundary as described, including but not limited to all pedestrian ways. (a portion of PIN 00099693)
