- During the month of April, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 7 day and 12 residential program visits.
- Jondoh House, LLC. was added as a new affiliate in April. Jondoh House provides residential and day supports. The agency is in the process of completing all the necessary paperwork to begin providing services.
- Dee Nighswonger, SCDDO Director, participated in VISTA Site Supervisor Training in preparation for recruitment to fill three AmeriCorps/VISTA Service Opportunities with the Department. Recruitment is on-going until positions are filled.
- Budget presentations to the County Manager's Budget Team took place in April. SCDDO Director presented on the department's budget needs for 2023 on April 18th.
- Jeannette Livingston, Deputy SCDDO Director, attended a community after action and planning meeting hosted by the Sedgwick County Health Department. The meeting functioned as a formal debrief of the COVID – 19 pandemic response. Community stakeholders met to discuss their experiences, what went well, what could be improved and what should be done to prepare for future pandemics. A final report will be completed and shared.
- In April the Deputy SCDDO Director visited the Envision Arts Gallery. Among other things, Envision is an affiliated provider that serves individuals with intellectual/developmental disabilities (IDD) with visual impairments through a day program. The Envision Arts Gallery is designed to empower artists and audiences who are blind, visually impaired and/or disabled by offering an accessible, diverse and inclusive space for the

arts. Sarah Kephart, Envision Arts Program Manager, reached out to the SCDDO to connect with artists with IDD with the goal of including their art in Envision's gallery.

• The 2022 graduating class of Project SEARCH interns were recognized at the April 20th meeting of the Sedgwick County Board of Commissioners. Interns were personally acknowledged during the meeting, received a certificate and Sedgwick County coin. The Commission also took a picture with the interns and their teachers. After the recognition at the Commission meeting, interns, their family and supervisors enjoyed cookies and punch at a reception in the County Manager's Office.
