- During the month of February, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 16 day program and 17 residential visits.
- Steven Hale, Sr. Partnership Specialist with the U.S. Census Bureau, provided an overview of the 2020 census process at the Sedgwick County Affiliate Directors Meeting on February 14th. In particular, Steven covered the requirements for agencies responsible for what the census refers to as "group quarters" i.e. congregant living settings such as group homes. These agencies are expected to facilitate the census information for all individuals in their group quarters. Parents/guardians should not count their child/ward in their household for the census if they live in group quarters. Census invitations should start going out in the mail during the middle of March. - As part of a capacity expansion grant, Disability Cocoon hosted an Introduction to Technologies event February 25th. The workshop was free for Sedgwick County affiliates and parents/guardians interested in learning more about how technology can be used to support the independence of individuals with disabilities. At this event, attendees learned how other IDD providers are using technology to address everyday challenges, gained insights into how to incorporate technology into service planning and discovered technology solutions that can meet their specific needs.

 Deidre Manis, completed a 6 week on-line course on the Mental Health Aspects of IDD for Mobile Crisis
 Responders. COMCARE was pleased to receive the training and looks forward to sharing it internally with staff.

- The department received approval to move forward with the purchase and implementation of a new electronic record keeping software to replace the current system that will reach end-life in 2020.
- Melissa Walker, with WSU's Hugo Wall School, presented the results of the Transportation Study to the Access Advisory Board on February 26th.
