\*\*Fully vaccinated data is reported as cumulative instead of weekly. Fully vaccinated: COVID-19 vaccine was first available to select populations starting in December of 2020. Availability expanded to everyone 16+ in April of 2021. 12+ vaccines were available starting in November 2021. 5+ vaccines were available starting June of 2022.

\*\*\*Booster vaccination data is reported as cumulative instead of weekly. Percent of residents who received a 3<sup>rd</sup> dose (immunocompromised) and booster are combined based on data received from the Kansas Department of Health and Environment. 3rd/Boosters: 3rd doses and/or boosters first became available in August of 2021. Boosters expanded to all adults 18+ in November of 2021. Availability expanded to 12+ in January of 2022.

\*\*\*\*Vaccination data lags compared to case data, so is not available for the most recent full week.
