# **Directors Report – Jeannette Livingston**

Sequential Intercept Model (SIM) Workshop

- Tool to look at each intercept in the criminal justice system to divert people from going further into the system
- Sedgwick County will be the first in the nation to do this for people with disabilities
- They are still working on the report

# **Project ECHO Immersion Training**

 Dee and Heather participated in this training for working with people with IDD and co-occurring behavioral health conditions

# Direct Support Professional (DSP) Badge Program

- The DSP Badge Program at WSU has started
- SCDDO is providing scholarships to DSPs for the program
- · Goodwill sent all their DSPs and will pay extra to all their DSPs that have the certification
- WSU is providing scholarships to high school seniors in Wichita and Haysville

### Registered Apprenticeship Program for DSPs

- Wichita Workforce Alliance and stakeholders met to discuss a Registered Apprenticeship Program for DSPs
- InterHab applied for a grant to start the program statewide

# **Provider Updates**

- Jeannette is working on renewing affiliation agreements with providers
- Elite Adult Living has given notice they are going to close
- KETCH is discontinuing targeted case management services
