- During the month of August, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 8 day and 8 residential program visits.
- Jeannette Livingston, Deputy SCDDO Director, gave a presentation on the SCDDO and system to support individuals with intellectual/developmental disabilities (IDD) for CASA's in Sedgwick County. CASA stands for Court Appointed Special Advocate. CASA's are trained volunteers appointed by judges to advocate for children in the foster care system.
- GoodLife Innovations hosted an open house to unveil their neighborhood network apartments. The
 neighborhood network offers semi-independent adults with IDD a safe independent living option utilizing
 supportive technology.
- As is the annual expectation, KDADS requested all CDDO's verify individuals listed on the Home & Community Based Services (HCBS) IDD Waiver statewide waiting list. The goal was to contact everyone on the waitlist to confirm they are still requesting HCBS IDD Waiver services. Sedgwick County currently has 983 individuals listed on the Statewide HCBS IDD Waiver waiting list. The CDDO sent a certified letter and form to all 983 individuals requesting they confirm contact information and continued interest in waiting for HCBS services. For individuals that do not respond, the CDDO will also try to make contact by phone. Results of the outreach will be provided to KDADS.
- Jeannette Livingston, Deputy SCDDO Director, gave a presentation on the SCDDO and system to support individuals with IDD at the Goddard Public School Parent Night. Around 20 or so parents of children with IDD attended.
