- During the month of October, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 1 day and 4 residential program visits.
- Sedgwick County recognized Disability Employment Awareness Month (DEAM) at the October 5th meeting of the Board of County Commissioners. Melissa Sutton, Instructor with Goodwill's Adult Project SEARCH, accepted the proclamation. Two successful program graduates, Daniel Roberts and Aaliyah Nelson, joined Melissa in accepting the proclamation.
- The SCDDO hosted a listening session with Sedgwick County affiliated agencies to gather input on priorities for state aid funding. SCDDO uses 100% of its state aid for services to individuals with intellectual/developmental disabilities (IDD). Agency representatives reviewed the prior year's state aid budget, discussed current issues that might impact the need or focus of state aid and ranked their funding priorities. SCDDO staff took this information and developed a funding plan which was sent to the Kansas Department on Aging and Disability Services (KDADS).
- SCDDO Management Team attended the annual InterHab Conference Oct. 12th through the 14th in Wichita. InterHab is the state association for IDD system advocacy. The conference featured a variety of speakers and sessions. The key note address and several of the conference sessions focused on how to hire and retain quality direct support professionals.
- In October SCDDO staff worked hard to make contact with everyone on the waitlist for IDD waiver services in an effort to confirm those on the waitlist wanted to continue to wait for services. The process started with a letter sent certified mail. If no response was received from the letter, SCDDO staff called them. Of the 983 individuals on the waitlist. 41 were removed.

- KDADS made service offers to 60 individuals on the statewide waitlist. SCDDO received 21 of those offers and is currently following up with these individuals to ensure they received the offer and respond whether they would like to access the services or not.
- The Sedgwick County Developmental Disability Community Council met Friday October 28th. Mindy Bowdre and Aaron Brown with Assistive Technology for Kansans (ATK) presented on technology to assist individuals with disabilities and available funding sources for this technology. The presenters demonstrated several pieces of technology include adapted telephones, pill dispensers and adaptive gaming controllers.
