On the recommendation of Lee Barrier, on behalf of Enterprise Resource Planning, Tim Meyers moved to accept the quote from HR Focal Point, LLC at the contract rate listed above for a term of five (5) years. Brandi Baily seconded the motion. The motion passed unanimously.

This extends the existing SAP HCM (Human Capital Management) Professional Services agreement that originated in 2015 for an additional five (5) years.

Over the course of the past seven (7) years, several other agreements for additional SAP SuccessFactors Modules have been signed: Recruiting & Onboarding in 2019, Employee Central & Employee Central Payroll in 2020, and Performance & Goals and LMS (Learning Management System) in 2021. All of these are five (5) year agreements.

No change from the existing agreement except a small increase in the hourly rate (was \$170.00/hr. now \$180.00/hr.).

### **Questions and Answers**

Brandi Baily: How much do you spend annually on average?

Mike Elpers: It varies quite a bit. It is based on the initiatives that are taken within HR and within Payroll. Since 2018, it's varied from the low of \$13,940.00 all the way up to \$42,245.00. That \$42,000.00 was actually in this year, in 2022, due to a new benefit provider for COBRA as well as well as several compensation adjustments that were made throughout the year. It just varies with the amount of activity that is going on in HR.

Tim Myers: I see we only have a small increase of the hourly rate from what it was the previous contract. \$10.00 an hour, is that correct?

Lee Barrier: Yes.

On the recommendation of Jamiee Witmer, on behalf of various departments, Joni Wilson-Colby moved to establish a contract with Amazon Business utilizing the Harris County, Texas Department of Education/Choice Partners Contract #22/045KN-01, in effect through August 16, 2023 with options to renew for four (4) additional one (1) year periods. Brandi Baily seconded the motion. The motion passed unanimously.

Through Choice Partners, Amazon Business was awarded a competitively solicited contract, which offers state-level and agency-level public sector organizations a compliant contract vehicle and meets all 2 CFR 200 Uniform Guidance.

As an Amazon Business Prime member, Sedgwick County acquires business-only pricing across 11 categories with quantity price breaks and free shipping. Currently, there are more than 7,000 small/medium businesses selling on Amazon that are based in the state of Kansas.

Harris County, Texas Department of Education is the lead agency who conducted a competitive solicitation process and received twenty (20) sealed proposals.

## **Questions and Answers**

Brandi Baily: To clarify, this is not a change from what we currently have now it is just an extension to be able to use them longer, is that correct?

Jaimee Witmer: It won't change anything currently for Sedgwick County. This is just a different cooperative agreement with Amazon. Our current contract is through Omnia Partners. We'd like to use the new cooperative, it is really attractive with the 2 CFR 200 Uniform Guidance which is something they really look for with Federal Funding - ARPA, things like that. It is just an extra level of protection for items that might be purchased from ARPA funds. That is why we are making the switch. As far as Sedgwick County shoppers and things like that, everything will be the same.

Brandi Baily: The pricing will still be similar?

Jaimee Witmer: Correct, still free shipping with one (1) to two (2) day shipping on most items. Everything will remain basically the same.

### **Questions and Answers**

Brandi Baily: When you say you would like to add them as a Valued Added Reseller, don't we already use Dell, or am I misunderstanding what this is?

Lee Barrier: No, we do use Dell and I'm going to let James explain why we are adding them as Valued Added Reseller.

## Brandi Baily: Adding Dell as a second vendor?

Lee Barrier: It's adding the option to use Dell software and hardware that we don't use now. For instance, we have a contract with SHI for our licenses. Dell also offers that software that we don't have right now. So this would be a way for us to keep competitive pricing with SHI. James can probably explain it better.

James Arnce: This is just the addition of us being able to use software through Dell. Currently we have PC servers, that kind of hardware where you go directly through them, we already have that established. Our contract has come up I believe with VMWare which is part of the software portion. So that falls under back up of all of our virtual systems. This would also, like Lee mentioned, it would give us the ability to compete with SHI. Currently when we go to buy software, SHI is our only option. If we need to go out and look at different pricing to compete, we only have only option. This would allow us to expand that to be able to look at other pricing options.

### **Questions and Answers**

Brandi Baily: Is Logicalis the new vendor that we are looking at to add or is it still Cisco?

James Arnce: Logicalis. Cisco would actually be the product we are purchasing. Again it kind of goes back to that last contract we are adding more vendors to be competitive in pricing.

Tim Myers: So we aren't saying we're actually going to use this vendor, we're just adding them in case they are better at pricing and that way we could utilize them?

James Arnce: Correct.

Russell Leeds: How many approved vendors do we have currently have right now to buy these switches?

James Arnce: Currently right now, one (1). This would add a second one. In the future, we are looking to add a third one.

Tim Myers: We're just trying to add these vendors so we can be more competitive?

James Arnce: Correct. So we are not just limited to one (1) vendor and kind of pigeon-holed right there.

Russell Leeds: These switches are fairly pricey, is that correct?

James Arnce: It depends on what you are buying. Normally, you are looking at \$2,000.00 to \$10,000.00 range depending on what you are needing.

On the recommendation of Theresa Rhodes, on behalf of 18th Judicial District Court - Court Trustee Non IV-D, Brandi Baily moved to **accept the proposal from Red Spade Investigations, Inc. and establish contract pricing for a** period of two (2) years with three (3) one (1) year options to renew. Russell Leeds seconded the motion. The motion passed unanimously with Joni Wilson-Colby abstaining from the vote.

A review committer comprised of Leilah Arnn, Lisa Long-Horton, amd Carl Wheeler - 18th Judicial District Court, Court Trustee Non IV-D; and Theresa Rhodes - Purchasing, evaluated all proposal responses based on the criteria set forth in the RFP. The committee unanimously agreed to accept the proposal from Red Spade Investigations, Inc.

In the enforcement efforts of the office there are times it is required to serve parties with various court documents. The most common document that requires personal service of a party is a contempt action. A contempt action is a civil action prepared that needs personal service to proceed within the courts. These actions are prepared when all other enforcement remedies in the office have been unsuccessful. The goal of the Court Trustee Office is to collect the money owed on these child support and spousal maintenance cases.

This is a proposal and not a bid. Proposals are scored based on criteria set forth in the RFP. There were four (4) components to evaluate.

Sedgwick County Court Trustee is an agency within Sedgwick County District Court that enforces Non IV-D Child Support and Spousal Maintenance cases. Any case filed after February 1, 1996 and is not referred under the Federal IV-D program falls under this category. All orders for payment of child support, except temporary orders, are assigned to the Court Trustees Office for monitoring and enforcement unless a "good cause" exception is granted by the Administrative Judge. There is a 3.5% fee of the support collected used to defray the expenses of operating this department. The Court Trustee's Office is a self-funded department from the fees collected.

# **Questions and Answers**

Brandi Baily: Do we use either one of these vendors who responded currently?

Leilah Arnn: No, we do not use either one of these vendors currently.

Brandi Baily: So our current vendor did not respond?

Leilah Arnn: They did not. We actually do not have a contract with the current vendor. The company that currently serves for us is a vendor who the State of Kansas IV-D offices use and when the IV-D office was still in the courthouse, before our contract was lost, did serve our actions as well but they were sent the proposal and did not respond.

Brandi Baily: What kind of pricing do we pay now as to comparison to what it was issued in the proposal?

Leilah Arnn: Right now it's \$55.00. We may get one (1) or two (2) a month.

Brandi Baily: We're asking to go with Red Spade, do we know the price comparison? Over the five (5) year period it's almost double the price. Is there a good reason why we didn't go with the other bid?

Leilah Arnn: Red Spade has multiple employees to go and serve and the other is just a single process server who serves for a large law firm here in town. We don't think he will be able to keep up with the quantity we are going to send him.

Brandi Baily: Is Red Spade local?

Leilah Arnn: Yes.

Brandi Baily: What do you spend currently annually?

Leilah Arnn: I don't have an annual figure but I know that the most I've had served in the last few months is six (6).

Russell Leeds: How is this fee collected across the state?

Leilah Arnn: The enforcement fee that is collected off of the cases that we enforce is what will pay for this.

Russell Leeds: So essentially the people we are serving to will pay for the cost of this indirectly or directly?

Leilah Arnn: Yes.

On the recommendation of Joe Thomas, on behalf of Risk Management, Tim Myers moved to **accept the insurance premium renewals as listed for an estimated total cost of \$440,071.10.** Joni Wilson-Colby seconded the motion. The motion passed unanimously.

The insurance premiums reflect minimal changes from last year's quotes. However, there was an increase in the premium renewal for Excess Workers' Compensation mainly due to an increase in payroll.

The premium listed for aviation coverage is for the county's current airplane.

Notes: Last year's premiums totaled was \$419,247.02.

### **Questions and Answers**

Brandi Baily: In personal life, they say it's good to shop around for insurance coverage. Do we shop around?

Elizabeth Wingo: We purchase our insurance through a broker and so the broker does go out and get multiple quotes if it's available on the line of insurance. Most of these only have one (1) person offering insurance on a lot of these lines right now.

Brandi Baily: Is Travelers who we currently have right now?

Elizabeth Wingo: For just two (2) of the policies, Crime and Public Officials. The rest of them are spread out.

Brandi Baily: I see.

Tim Myers: Even with the increase in the premium in Excess Workers' Compensation and the increase in payroll, we're still looking at \$20,000.00 over what we paid for last year?

Elizabeth Wingo: Correct. Given the state of the insurance market, we were incredibly pleased with the quotes we got this year.
