- i. Dorsha Kirksey provided updates from the Transit Advisory Board
1. The Multimodal Center building concept has been presented to the Design Council. This design will be presented to the Access advisory Board when the design is around 70 % complete
 2. Orientation and travel training for small groups has improved
 3. The Downtown Parking Plan will be moving into a more urbanized model. The downtown grid is planned to be more walkable
 4. The City Manager has requested that the Transit Advisory Board and the Bike Pedestrian Board be combined into one board.

1. The Kansas Public Transit Association Meeting will take place May 29th through the 31st
 2. There are several pilot programs underway with multiple agencies. Data is being gathered for these programs

- iii. There are paratransit services that go to the front doors of Town East. Most of these were for shopping rather than work
- iv. Town East is looking to revise their land use policy through planning. Wichita Assistant City Manager Kathy Sexton is engaged with the senior management of Simon Properties

- i. The Transit Maintenance Facility has been entertained as an alternate meeting venue
- ii. This location has been reserved for the next 6 months and can be used as an alternate meeting venue if the Board desires
