- During the month of November, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 8 day and 8 residential program visits.
- During November, the youth Project SEARCH interns participated in mock interviews. Several Sedgwick County staff served as interviewers including Steve Stonehouse, Kelly Rowlett and Joselin Alfaro-Escobar with Corrections. Chole Hall and Jane Link with Sedgwick County Human Resources and Surandika Senevirantne with COMCARE also served as interviewers. Additional mock interviews will be scheduled in the spring, so the interns will be skilled up and ready for interviews as part of their job search.
- Jeannette Livingston participated in a HCBS Settings Final Rule webinar entitled, "Themes Identified During CMS' Heightened Scrutiny Site Visits." In this webinar, federal staff discussed the issues found as they have begun doing site visits to determine compliance with the Settings Final Rule. As of the webinar, seven states have received a site visit (Kansas is scheduled for early 2023). A few of the issues identified through the site visits included person centered support plans (PCSP) were not always available onsite and/or didn't include all providers. The staff conducting the site visits also expected staff to be trained and understand the characteristics of home and community based services, as opposed to institutional or isolating settings. Another unexpected finding was that the federal staff clearly expected "community engagement" to be more individual activities instead of group trips.
- November 9th and 10th, Sherry Arbuckle attended the Kansas Sequential Intercept Model Summit (SIM). The SIM focus was to develop a map that shows how individuals living with I/DD, mental health, and substance use disorders navigate the legal system. Participants included individuals from across the state representing KDADS, Mental Health, Department of Corrections, Law Enforcement, Self-Advocates, Substance Abuse, CDDOs and

I/DD Community Services Providers. Participates developed ideas for treatments to improve response. There were three primary objectives for the Sim Conference:

The development of a comprehensive picture of how people with mental and substance use disorders enter and move through the criminal legal system along six distinct intercept points.

The identification of resources, gaps in services, and opportunities at each intercept for individuals in the target population.

The development of priorities for change and strategic action plans.
