Brandi Baily: I don't know, I'm just thinking, is this the cheapest solution for the county? Is there another vendor out there that could provide the same service? Maybe even if it includes their equipment?

Kendal Ewing: I don't know if I have the answer for that. I think in order to go with a different vendor, they would have to come in and tear out all of Stanley's equipment and then reinstall, so at that point it would not be the cheapest.

Brandi Baily: Are we happy with the service they provide?

Kendal Ewing: Yes.

Russel Leeds: Do we have an estimated cost on what it would take to replace the whole thing? Were talking a million, a million plus, you think?
