#### **Under-Stair Protection**

#### PROTECTION OF STAIRS IN FIRE RESISTANT CONSTRUCTION

Often times the area under a stairway is used for storage. This space is often accessible after the construction process is complete. To protect inhabitants and First Responders during a fire event rescue or egress operation, the code requires that stairways have fire protection as prescribed in IRC 302.7.

#### **R302.7 Under-Stair Protection**

Enclosed space under stairs that is *accessed* by a door or access panel shall have walls, under-stair surface and any soffits protected on the enclosed side with  $\frac{1}{2}$ -inch (12.7 mm) gypsum board.

Sedgwick County MABCD requires that the space underneath the stairs be fire resistant construction, or be made inaccessible to prevent the storage of combustibles.

# 2023 NEC (National Electrical Code) Review with Amendments in Full Swing


The 2023 NEC which was issued by the Standards Council on August 12, 2022, with an effective date of September 1, 2022, and supersedes all previous editions. Is now under review by MABCD.


An 11 member code review committee has been assembled to review the significant changes to the 2023 National Electrical Code.

The code review committee consists of many industry professionals, engineers, both Union and Non-Union representation, residential, commercial, industrial construction industry representation, and staff expertise.

The Code Review Committee is dedicated to involving as many industry partners and stakeholders as possible. This review process which started December 2022 will take almost 12 months to review, prepare for adoption, hold a public hearing and finally adopt for enforcement.

MABCD staff and the Code Review Committee are committed to continuing to provide a process of excellence with a thorough review of the most current available electrical code, for the safety of Sedgwick County.

# Inspections of Sanitary Sewer replacement and repair at the Sanitary Sewer Main.

All repair or replacement of sanitary sewer piping in the city of Wichita requires a sewer permit issued by MABCD.

The preferred method for submission of Sewer permit applications is on the MABCD Dynamic Portal.

Sewer permit applications may be made in person by calling 316-660-1840 to schedule an appointment to meet with the sewer permit technician.

Failure to obtain an appointment may cause extended delays and wait times.

Inspections for repairs at the sanitary sewer main must be scheduled online through the MABCD Dynamic Portal and by phone with the City of Wichita Public Works Sewer Maintenance division dispatch coordinator at least one day in advance of the excavation work. The contractor must contact the Sewer Mainte-

nance Tap Crew scheduling coordinator by calling 316-268-4025 to reserve a time slot on their calendar.

There is a limited number of time slots available therefore contacting the tap crew coordinator as many days in advance as possible is highly recommended.

The Tap Crew has the specialty tools and training to inspect and repair connections to the sanitary sewer main where the main is constructed of Vitrified Clay Tile pipe (VCP), CIPP lined VCP pipe, ABS plastic and concrete truss pipe.

New connections where the sanitary sewer main is VCP, CIPP lined VCP pipe or ABS plastic and concrete truss pipe must also be scheduled with tap crew coordinator at 316-268-4205 for the installation of a new PVC saddle.







# Wichita Fire Department-

# <u>Access for Fire Fighting</u> & Water Supply for Fire Protection

### SECTION 3310 ACCESS FOR FIRE FIGHTING

3310.1 Required access. Approved vehicle access for fire fighting shall be provided to all construction or demolition sites. Vehicle access shall be provided to within 100 feet (30 480 mm) of temporary or permanent fire department connections. Vehicle access shall be provided by either temporary or permanent roads, capable of supporting vehicle loading under all weather conditions. Vehicle access shall be maintained until permanent fire apparatus access roads are available.

# SECTION 3312 WATER SUPPLY FOR FIRE PROTECTION

**3312.1 When required.** An *approved* water supply for fire protection, either temporary or permanent, shall be made available as soon as combustible material arrives on the site.
