Administration-

Cancelling Inspections

If an inspection needs to be cancelled, it must be cancelled by phone through the dispatcher or directly with the inspector.

Cancellations cannot be processed through the MABCD portal because the information does not transfer to the assigned inspector, and so the inspector then makes an unnecessary trip.

All cancellations must be cancelled by phone to the dispatcher or directly to the inspector prior to the scheduled time of the inspection or a reinspection fee may be assessed.

Important update

Regarding the enforcement of UBTC (Unified Building and Trades Code): Sections 4.2.037 (NEC Section 230.95(C)

&

Sections 4.2.038 (NEC Section 240.67(C)

After much discussion, MABCD with the approval of the BEA have agreed to forgo the following requirements until further notice.

Sec. 4.2.037. – Ground Fault Protection of Equipment – Performance Testing.

Section 230.95(C) of the National Electrical Code (NEC)

Performance Injection Testing will not be required.

Sec. 4.2.038. – Arc Energy Reduction – Performance Testing.

Section 240.67(C) of the National Electrical Code (NEC)

Performance Injection Testing will not be required.
