- During the month of March, Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 5 day and 3 residential program visits.
- Sedgwick County celebrated the 2023 Project SEARCH graduates at the April 19 Board of County Commissioners
 meeting. Of the three Project SEARCH Interns, two had started jobs. A reception was held immediately after

- The Kansas Department on Aging and Disability Services (KDADS) hosted an IDD Waiver Renewal Stakeholder Kick-off event on April 26. The Kansas Medicaid waiver for intellectual/developmental disability services is set to expire soon. An updated waiver application must be submitted to the Center for Medicare/Medicaid Services (CMS) by January 2024. KDADS has identified the below areas requiring changes for the waiver application and is asking for stakeholder input on these areas:

1. Conflict of Interest in CDDO and TCM -

CMS identifies the practice of case management and waiver assessments being rendered by the same service provider for waiver participants as a conflict of interest.

2. Unbundling Day Services -

KDADS must be able to identify service delivery by appropriate service codes to clarify setting types for CMS. For example, unbundling day supports from vocational training/sheltered workshops.

3. Unbundling Residential Services -

KDADS must be able to identify service delivery by appropriate service codes to clarify setting types for CMS. For Example, distinguishing shared living from independent living and group homes.

4. Ratio Billing -

Ratio billing needs to be better defined to make sure Kansas is operating within federal regulation.

5. Supported Employment –

Kansas needs to address how to bill at a competitive rate. It also needs to ensure services are being delivered in an integrated competitive setting. Actions have already started through the Employment First initiative to bring Kansas in line with competitive rates.

6. Functional Assessment (BASIS/MFEI) -

There is consensus amongst most stakeholders to move away from BASIS. Currently, day and residential funding are tied to the BASIS score. As Kansas moves away from this assessment format with the MFEI, it must find a way to determine funding levels for IDD waiver services that are not connected to the level of care assessment.

7. Assistive Technology -

Technology can be used to increase people's independence. Kansas must develop policies and standards to assure the use of technology is person-centered. An ARPA funds initiative is in place to gather information on assistive technology.

- Sherry Arbuckle, SCDDO Service Access and Operations Director, attended the ANCOR Conference in April. The
 conference featured some of the leading experts and advocates for the Development Disability system. Below is
 a list of the trends for IDD system identified at the conference:
 - Small, not for profits will need to collaborate and partner to survive.
 - o IDD agencies need to utilize data, not just collect data because they are supposed to. Also it is important to teach the individuals we serve how to use their data
 - ANCOR has developed a White paper on alternative payment options for the IDD system to include value based pay.
 - Artificial intelligence (AI) could have application in the IDD system. The session demonstrated how AI could be used to review many years of case notes, categorizing case notes in a manner that could be graphed to assist the individual and team to see trends in behaviors etc. The team reviewed the AI outcomes and found there was only a low percentage of case notes categorized incorrectly.
