The following is to ensure that vendors have complete information prior to submitting a proposal. Here are some clarifications regarding the proposal for Prevention/Early Intervention Services.

Questions and/or statements of clarification are in **bold** font, and answers to specific questions are *italicized*.

1. What are the current programs being funded with the Crime Prevention dollars?

Answer: Currently funded programs include:

- a. *Center for Behavioral and Academic Research (CBAR) – McAdams Academy – Educational Services for Expended/Expelled Students*
- b. *Community Solutions, Inc. (Multisystemic Therapy)*
- c. *Mental Health Association of South Central Kansas – PATHS Program – School Based*
- d. *Seventh Direction, Inc. – Substance Abuse Treatment and Sober Living Houses*
- e. *Untamed Athletes, Inc. – Recreation Based Mentoring and Tutoring*

In addition, a portion of prior funding was utilized for administration support/consultation and training needs.

2. Can the grantee get trained by someone from the county on either the RFR (Risk for Re-Offending) or the YLSCMI?

Answer: SCDOC can provide training on the RFR. The YLS/CMI is a state assessment and providers have to have approval and be trained by a YLS/CMI trainer.

3. Where would referrals for the programs come from?

Answer: The program needs to be planned with known resources for referrals in mind. Proposers need to contact their potential referral sources and get some estimates of numbers and characteristics of possible referrals. Those would/should be an integral part of the response to the RFP.

4. **On the appendix A budget sheet: "annual county contract budget" and "annual other contract budget", etc. can there be more clarity provided on what should be included in these columns?**

Answer: Please feel free to utilize the form to add in relevant line items to your proposal if they are not covered in the list provided.

5. **What is the allowable indirect amount?**

Answer: As per input during the pre-bid meeting, the focus of the funding should be on direct services to clients. You can put indirect projections in your proposal for consideration by the committee but priority consideration will be on use of funding for direct services.

Firms interested in submitting a **proposal**, must respond with complete information and **deliver on or before 1:45 pm September 26, 2023**. Late **proposals** will not be accepted and will not receive consideration for final award.
