- I. Welcome, Announcements & Introductions – Brian Powers
 - a. Roll Call of the Meeting Attendees, Quorum present
- II. Meeting Minutes

- III. Committee Updates
 - a. Towne East Mall Access
 - i. Nothing has changed since the September WSCAAB Meeting.
 - b. Transportation Committee
 - i. Raven mentioned that ridership has increased back up to pre-COVID numbers.
 - ii. Raven also mentioned that Wichita Transit is working on a plan for electric on-demand vehicles and infrastructure.
 - c. Intrust Bank Arena
 - i. A representative from Intrust Bank Arena was at the meeting to answer questions, and gather information regarding concerns.
 - 1. It was mentioned that during one of the summer specials, ADA seating was not available at every price level, and the seating that was available was very limited.

2. Andrew mentioned the 36" clearance for seating to allow space for guide dogs, the IBA rep responded that the assigned ADA platforms do have that 36" clearance, but that she would have maintenance check to make sure that was still accurate.
3. Tom also noted that the select-a-seat website is not compatible with screen readers, and that he would like to talk with a select-a-seat representative regarding this concern.

- a. Side Walk Closures around the Kansas Health Science Center-
 - i. Andrew asked when these renovations would be finished, and when he could expect the sidewalks along Douglas to be reopened
 1. Gary responded that staff is currently working on a plan to get the sidewalks open, but that no official date had been set.
