SUBJECT: PREA Committee Review for *July*

On August 24, 2023, the PREA Committee met and present were the following: Capt. Paula Smith, HSA (Health Service Administrator) Ryan Fickle, BHC (Behavior Health Coordinator) Logan Reich, and Lt. Todd Hallacy (PREA Coordinator).

We conducted a review of 46 PREA complaints.

This review consisted of 13 **substantiated** cases. Those cases were:

This review consisted of 5 **incidents not arising to PREA standards**. Those cases were:

PREA-2023-000050, 2023-000342, 22S010155, deputies reports X 2.


In reviewing each of the cases, the committee determined policy was followed; nothing occurred that could have prevented the incidents from happening. There were no signs to make an indication, in either circumstance, a sexual abuse would occur.

In each case review, the committee potentially found no indication either incident was motivated by race, ethnicity, gender identity, lesbian, gay, bisexual, transgender, or intersex identification, status, or perceived status.


The committee also determined there was no indication of gang affiliation, nor was any of the incidents motivated by or otherwise caused by other group dynamics within the facility.

The committee also determined the area in which the incidents occurred. The physical barriers in the place had no effect on the abuse and the staffing level was adequate.
