- 1. Can you give me an idea of the budget you have allocated for this initiative: RFP #23-0084, Training for Healthcare Providers on Substance Use Disorder and Clinical Practice Guideline for Opioid Prescribing and Pain Management as part of the OD2A: Local Grant?**

Answer: The budget for RFP #23-0084 is outlined on page 5 of the RFP, but is also included below for reference. Year 1 includes additional funding to support initial implementation of the training series. Funding for each year may vary, will be monitored by SCHD, and will have a do not exceed annual amount as outlined in the table.
