Discussion:

**Jim Benage** - I will second to the motion. But I would like to make a comment for the record. I think that this is the right thing to do and the reason is the purpose of unions is to help management make sure that the members of the union needs are properly addressed. And I think in the short tenure of this committee, we've seen a couple of situations where that just wasn't happening and I think it's because of that, that it's wise for the Fire Board to adopt or reinstate recognition of the union.

**Susie Sutton -** I'm also in support of it. But I would like a comment added that I am in support of it also because it allows the Chief (Williams) to focus on running the fire department instead of constantly addressing issues with the management of Sedgwick County. Instead of taking away his attention from running a fire department by having the union and a contract with the union, everything will be laid out for three (3) years at a time. So he won't have to fight constantly [to] negotiate different policies.

**Katy Jackman Tyndell -** Okay, I would make a motion then to amend the current motion that's on the agenda to just delete everything after PEERA.

**Andy Hall -** So I'll amend my motion, amend my motion to remove the recognition of the local 2612 as the official collective bargaining agreement.

Jim Benage - All right I second the amended motion.
